### READ ALL DIRECTIONS COMPLETELY BEFORE USE

#### SHAKE WELL BEFORE USE

For most effective results, follow directions for specific use areas.

Use this spray as a spot or crack and crevice treatment to localized areas where pests are found or may occur to control listed insects. Spray surfaces until wet but not to the point of runoff. Repeat as necessary.

Avoid contamination of food and animal feed. Do not apply in classrooms when in use. Do not apply this product in occupied patient rooms or in any rooms/areas while occupied by patients, the elderly, or infirm. Do not apply in institutions (including libraries, sports facilities, etc.) in the immediate area where occupants are present.

#### FOR SPOT TREATMENT:

TO KILL COCKROACHES [Brown Banded Cockroaches, Asian Cockroaches, German Cockroaches, American Cockroaches, Australian Cockroaches] Water Bugs, Palmetto Bugs, Crickets, Black Widow Spiders, Firebrats, Silverfish, Scorpions, Spiders, Centipedes, and Sowbugs: Contact as many insects as possible with this spray. Thoroughly spray areas suspected of harboring these pests. Special attention should be paid to hiding places such as cracks and crevices, behind and beneath sinks, stoves, and refrigerators, around garbage cans and cabinets, along baseboards, door and window sills, door and window frames, on floors, around drains, pipes, and plumbing, behind bookcases, and in storage areas and other utility installation areas, hitting insects with spray who never possible.

TO KILL FLEAS AND TICKS: Prior to application, thoroughly vacuum all carpeting and upholstered furniture, along baseboards, under furniture, and in closets. Place vacuum bag in a sack and dispose of in outside trash. Thoroughly apply as a spot treatment to infested areas such as pet beds and cesting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floors and floor coverings where these pests may be present. EXPOSED STAGES of Confused Flour Beetles, Indian Meal Moths, Rice Weevils, and Saw-toothed Grain Beetles: Find and dispose of infested packaged goods. Remove all other items from pantry, shelves, and drawers and clean thoroughly. Spray into cracks and crevices, shelves, drawers, cabinets, and other areas where these insects tend to congregate. Place clean paper on shelves and return packages to shelves after spray has dried.

CARPET BEETLES: Directly spray as many insects as possible. Treat shelves and closets, floors, walls, windowsills, and baseboards, areas under furniture, and wherever these insects are seen or suspected.

ANTS: Treat doors, ant trails and hills, cracks and crevices, around window frames, and other areas of entry. Repeat as necessary.

FOR CRACK AND CREVICE TREATMENT: Apply spray in small amounts directly into cracks and crevices, points between different elements of construction, between equipment and floors, into openings leading to voids and hollow spaces in walls, and on equipment legs and bases where pests may hide.
