- b. Add the following paragraphs to the beginning of the Directions For Use section:

"Do not use in the edible product areas of food/feed processing plants, restaurants or other areas where food/feed is commercially prepared or processed. Do not use in serving areas while food is exposed or facility is in operation. Serving areas are where prepared foods are served such as dining rooms but excluding areas where foods may be prepared or held.

In the home, cover all food handling surfaces and cover or remove all food and cooking utensils, or wash thoroughly after treatment. Exposed food should be covered or removed.

Non-food/feed areas are areas such as garbage rooms, lavatories, floor drains (to sewers), entries, and vestibules, offices, locker rooms, machine rooms, boiler rooms, mop closets and storage (after packaging, canning, or bottling.)"

- c. The claims "Keeps killing for 8 weeks" and "Kills on contact" must be supported by efficacy data. Submit or cite appropriate efficacy data. (If you cite data, indicate the MRID No. and product tested). Please delete these claims from your label until you have submitted this information and gained Agency approval.

- d. Add an ENVIRONMENTAL HAZARDS statement as follows:

"This product is toxic to fish and aquatic invertebrates. Do not apply directly to any body of water.

3. Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

PHYSICAL OR CHEMICAL HAZARDS

**DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

**Shake well before use.**

**HOW TO USE:** Spray directly on listed pests whenever possible. Spray on ant trails and localized areas where ants come into the building. Use this product indoors as a spot or crack and crevice treatment, along baseboards, under and behind stoves, refrigerators, freezers, around plumbing pipes and fixtures, and other localized areas. Do not use as a space spray or broadcast surface spray. Spray surfaces until wet. Repeat as needed.

**CONTROLS:** Ants, Cockroaches (Waterbugs, Palmetto Bugs), Crickets, Centipedes, Firebrats, Silverfish, Spiders (including Black Widow Spiders), Scorpions, Earwigs, Carpet Beetles, Fleas and Ticks.

**TO KILL Ants, Cockroaches, Crickets, Centipedes, Firebrats, Silverfish, Earwigs and Carpet Beetles:** Spray areas where these pests are found or suspected, including corners of rooms and closets, along baseboards, cracks and crevices in walls, door and window frames, behind and beneath stoves, refrigerators, freezers, cabinets, and shelves, surfaces around garbage cans, plumbing and electrical conduits and other areas where these pests are seen.

**TO KILL Fleas and Ticks:** Spray areas infested with these pests, such as pet resting areas, pet bed areas, baseboards and localized areas of floors and floor coverings. Remove pet bedding and launder it before spraying or replace with new bedding after the spray has dried. **DO NOT SPRAY PETS WITH THIS PRODUCT.** Pets should also be treated with a registered flea and tick control product to eliminate these pests before allowing the pet to reenter the treated area.

**STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage or disposal of this product.

**STORAGE:** Store in a cool, dry place, preferably a locked storage area, away from heat or open flame.
