SPACE SPRAY - Undiluted in aerosol generators - To kill Ants, Boxelder Bugs, Cheese Mites, Cheese Skippers, Clover Mites, Earwigs, Exposed Accessible Stages of Flies, Fruit Flies, Gnats, Hornets, Mosquitoes, Small Flying Moths, Wasps and the following common stored product pests: Angoumois Grain Moths, Cadelles, Cigarette Beetles, Confused Flour Beetles, Dark Meal Worms, Drugstore Beetles, Grain Mites, Granary Weevils, Indian Meal Moths, Mediterranean Flour Moths, Red Flour Beetles, Rice Weevils, Sawtoothed Grain Beetles, Spider Beetles, Tobacco Moths and Yellow Meal Worms: Remove or cover exposed food and food handling surfaces. Close room and shut off all air conditioning or ventilating equipment. Apply at the rate of 1 ounce of undiluted concentrate per 1,000 cubic feet of space. Direct output from aerosol generator toward upper corners of room and ceiling. Leave room closed for 1/2 hour and ventilate thoroughly before re-entry. Do not apply this undiluted spray in facilities operating under USDA meat, poultry, shell egg grading and egg products inspection programs. Do not remain in treated area.

NOTE: If there is a need to treat such areas as conduits, motor housings, junction and switch boxes or other electrical equipment, detenergize electrical equipment prior to application. After application, allow time for oil to evaporate before starting motors or placing switches in the "ON" position.

<u>CONTACT AND SPACE SPRAY - Undiluted - To kill Ants, Crickets, Cockroaches, Earwigs, Silverfish and Spiders, in sheltered situations</u>: Contact as many insects as possible. Do not allow spray to contact stored food. Use at a dosage rate of approximately 1/2 fluid ounces per 1,000 cubic feet of room space. Do not apply more than once every 4 days for control. Leave the room closed for 1 hour. Do not remain in treated areas and ventilate area before re-entry. Do not apply this undiluted spray in facilities operating under USDA meat, poultry, shell egg grading and egg products inspection programs. The facility must not be in operation when used as a space spray or general surface treatment.

<u>SPOT, OR CRACK AND CREVICE APPLICATIONS - Undiluted</u>: Apply in specific areas such as: cracks and crevices in or behind baseboards, in floors, walls, expansion joints, areas around water and sewer pipes, wall voids, or voids in table legs and equipment where pests can hide as well as other similar areas. Spot treatments may also be made to areas including but not limited to storage areas, closets, doors and windows, behind and under refrigerators, cabinets, sinks, stoves, and other equipment, the underside of shelves, drawers and similar areas. Do not apply where electrical short circuits could occur.

DILUTED APPLICATIONS:

<u>SPACE SPRAY - Diluted for ordinary mechanical fogging equipment - To kill Flies, Gnats, and Small Flying Moths</u>: This concentrate is designed for use diluted in mechanical sprayers which gives particles of aerosol size (5-30 microns). Cover or remove exposed food and food handling surfaces. Close room and shut off all air conditioning or ventilating equipment. Dilute concentrate with oil at the rate of 1 part Concentrate plus 29 parts of oil or 4.5 ounces per gallon and mix well. Apply at the rate of 50 fluid ounces dilute spray (.4 gallons) per 25,000 cubic feet of space. Direct fog upward towards upper corners of room and ceiling area. Leave room closed for 1/2 hour. Do not remain in treated area. Ventilate room thoroughly before reentry.

<u>CONTACT SPRAY - Diluted for use with sprayers that give large, wetting spray particles to kill Cockroaches and Accessible Stages of Granary Insects:</u> <u>Cadelles, Confused Flour Beetles, Grain Mites, Granary Weevils, Meal Moth Larvae and Adults, Red Flour Beetles, Rice Weevils and Sawtoothed</u> <u>Grain Beetles</u>: Cover or remove exposed food and close room as described above. Dilute Concentrate with oil at the rate of 1 part Concentrate plus 29 parts of oil or 4.5 ounces per gation and mix well. Spray outside walls of grain bins, flooring, about base of milling machinery, walls and baseboards, areas behind cabinets, around pipes and other insect harborages using 1 gallon spray per 1,000 square feet of space. Do not apply more than once every 4 days for control.

To Kill Carpet Beetles: Dilute concentrate with oil at the rate of 1 part concentrate plus 29 parts of oil or 4.5 ounces per gallon and mix well. Apply to floor areas and baseboards. Treat both the underside and top side of infested carpets. Spray inside of trunks, closets and infested areas of shelving. Do not apply more than once every 4 days for control.

<u>SURFACE SPRAY - To insure maximum control of crawling insects: Ants, Boxelder Bugs, Clover Mites, Drugstore Beetles, Earwigs, Lice and Spider</u> <u>Beetles</u>: Dilute 1 part concentrate plus 29 parts oil (refined kerosene) and mix well and apply as a coarse wetting spray using approximately 1 gallon of spray mixture for 750 square feet of surface. Spray walls, floor and other surfaces of bins and storage and handling areas thoroughly, being especially careful to apply the spray into all cracks and crevices in woodwork, walls, floors, underneath sinks, behind pipes and in all places where these insects shelter. Treat unloading, handling and processing areas and inside conveying, processing and handling equipment. Spray thoroughly around the base of heavy machinery and equipment. Spray insects directly when possible.

<u>SPOT AND CRACK AND CREVICE TREATMENT: To insure maximum control of crawling insects: Ants, Boxelder Bugs, Clover Mites, Drugstore</u> <u>Beetles, Earwigs, Lice and Spider Beetles:</u> Dilute 1 part concentrate plus 29 parts oil (refined kerosene) and mix well and apply as a coarse wetting spray using approximately 1 gallon of spray mixture for 750 square feet of surface. Spot spray walls, floor and other surfaces of bins and storage and handling areas thoroughly, being especially careful to apply the spray into all cracks and crevices in woodwork, walls, floors, underneath sinks, behind pipes and in all places where these insects shelter. Treat unloading, handling and processing areas and inside conveying, processing and handling equipment. Spot spray thoroughly around the base of heavy machinery and equipment. Spray insects directly when possible.

STORED FOOD: (Stored in multi-wall bags or cloth bags) in flour mills, grain elevators, granaries, storage rooms, warehouses for control of Angoumois Grain Moths, Cadelles, Cheese Mites, Cheese Skippers, Cigarette Beetles, Confused Flour Beetles, Dark Meal Worms, Grain Mites, Granary Weevils, Indian Meal Moths, Mediterranean Flour Moths, Red Flour Beetles, Rice Weevils, Sawtoothed Grain Beetles, Yellow Meal Worms: Remove and destroy infested products. Dilute concentrate with oil at the rate of 1 part concentrate plus 29 parts oil or 4.5 ounces per gallon and mix well. Disperse this product first by directing spray into corners, under pallets and around stacks of packaged foods hitting as many insects accessible and then treat as a space spray. Infested stored products should be fumigated or treated by other effective methods using an approved product intended for this purpose. Use a dosage of 1/2 fluid ounce per 1,000 cubic feet of space. Do not remain in treated areas and ventilate the area before re-entry. This application will kill accessible, exposed stages of those stored product pests listed above. Sweep up and destroy fallen insects. Do not apply more than once every 4 days for control.

FOR USE IN FEDERALLY INSPECTED MEAT AND POULTRY PLANTS: For control of exposed or accessible stages of ANTS, EARWIGS, FLIES, FRUIT FLIES, GNATS, SILVERFISH, SMALL FLYING MOTHS, SPIDERS AND WATERBUGS. Dilute 1 part concentrate with 3 parts base oil (refined kerosene) and use with ULV spraying device at the rate of 1 ounce per 1,000 cubic feet of room space. Contact as many insects as possible. Before using, exposed food products and packaging materials must be covered or removed. After use, equipment and utensils must be washed with an effective cleaning compound and rinsed with potable water after use of the product. Use as a space spray only when plant is not in operation.

NOTE: When using oil as the diluent, an odorless light petroleum hydrocarbon as defined by CFR Title 21, 172.884 should be used for all food area and food related applications. Additionally, when diluted and used according to label directions, this spray will meet specifications for use under USDA meat, poultry, shell egg grading and egg products inspection programs.
