

Delete the statement, "and other animals used for show" wherever it appears on the label. This statement is too inclusive.


A stamped copy of the draft label is enclosed. Submit two copies of the finished label.

WARNING

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

Harmful if inhaled. Causes substantial but temporary eye injury. Do not get in eyes or on clothing. Avoid contact with skin. Avoid breathing vapor. Wear goggles, face shield, or safety glasses. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Remove and wash contaminated clothing before reuse.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

READ ENTIRE LABEL BEFORE EACH USE. USE ONLY ON FERRETS, DOGS, CATS, HORSES and other animals used for show. Follow all precautions and directions.

For use on Ferrets, Dogs, Cats, Puppies and Kittens over the age of 12 weeks, Horses and Other Animals Used for Show for the control of Fleas and Ticks. Do not repeat treatment for 7 days. Do not use on puppies and kittens under 12 weeks. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals. Sensitivities may occur using any pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

HOW TO USE: Wet the animal's coat with warm water for 2-3 minutes. Apply shampoo on head and ears and lather. Then repeat procedure with neck, chest, middle and hindquarters, finishing legs last, paying attention to the foot pads (between the toes) and the underbody areas. Wash the head and ear areas carefully, making sure to keep the shampoo out of the animal's eyes. **NOTE:** A drop of glycerin in each eye before bathing can prevent or reduce irritation if the shampoo gets in the animal's eyes. Pay special attention to the base of the tail, as it is a place frequented by fleas. Once the animal is "fully lathered", let stand for 5 minutes (this is an important part of grooming procedure) before rinsing thoroughly with water.

For small dogs and cats less than 15 pounds, it is advisable to wrap animal in a towel for several minutes to absorb moisture. This also will allow dying fleas and ticks to crawl off pet into towel before drying further with a towel or blow dryer.

Flea and tick control on the pet is only part of the solution to the problem. The inside of the house and the outdoor area used by the pet must also be treated for complete control.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry place. Keep container closed.

DISPOSAL:

If Empty: Do not reuse this container. Place in trash or offer for recycling if available.

If Partly Filled: Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.
