NOTE: A drop of glycerin in each eye before bathing can prevent or reduce irritation if the shampoo gets in the animal's eyes. Pay special attention to the base of the tail, as it is a place frequented by fleas. Once the animal is "fully lathered", let stand for 5 minutes (this is an important part of grooming procedure) before rinsing thoroughly with water.

For small dogs and cats less than 15 pounds, it is advisable to wrap animal in a towel for several minutes to absorb moisture. This also will allow dying fleas and ticks to crawl off pet into towel before drying further with a towel or blow dryer.

Flea and tick control on the pet is only part of the solution to the problem. The inside of the house and the outdoor area used by the pet must also be treated for complete control.
