PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

Harmful if inhaled or absorbed through skin. Avoid contact with skin, eyes, or clothing. Avoid breathing vapor or spray mist. Wear protective clothing and waterproof gloves. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. Applicators and all Handlers must wear: Long -sleeved shirt and long pants, socks and shoes, and chemical resistant gloves made of barrier l'aminate, nitrile rubber, neoprene rubber, or viton. ENVIRONMENTAL HAZARDS:

This product is toxic to wildlife and aquatic invertebrates. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes.

PHYSICAL OR CHEMICAL HAZARDS

Flammable. Contents under pressure. Keep away from heat, sparks, and open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Do not apply in a way that will contact people or pets directly or indirectly.

Do not use in commercial food processing, preparation, or food storage or serving areas. Non-food areas are areas such as garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets, and storage areas (after canning or bottling).

Remove pets and birds and cover fish aquariums before spraying.

Do not allow children or pets to contact treated surfaces until spray has dried.

Do not apply this product in occupied patient rooms or in any rooms/areas while occupied by patients, the elderly or infirm.

Use this spray as a spot or crack and crevice treatment to control GermanRoaches, Fleas, Silverfish, Brown Dog Ticks and other listed insects. Apply this product only as a coarse spray or crack and crevice treatment to localized areas where pests are found or may occur. Spray surfaces until wet but not to the point of runoff.

SHAKE CONTAINER WELL BEFORE USE. Point sprayer button at the insects to be sprayed or the surfaces to be treated and press down. Spray surfaces until lightly moist, moving the container to keep from excessively wetting the surface.

NOTE: Application to plants will cause damage. Rinse accidentally sprayed plants immediately.

Do not use as a space spray for flying insects.

FOR SPOT TREATMENT:

To Kill Ants (excluding fire, harvester and pharaoh ants), German Roaches, Crickets, Silverfish, Spiders (including Black Widow Spiders but excluding brown recluse spiders), Firebrats, Millipedes, Pillbugs and Sowbugs: Spray areas where these insects are found or may hide, including dark comers of rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators, and cabinets; and around garbage cans, plumbing and other utility installations. Will only kill pests present at the time of application. Pests must be directly contacted to be effective. Contact as many pests as possible. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance. Repeat treatment when pests appear, but not more frequently than 6 to 8 weeks.

To Kill Carpet Beetles: Directly spray beetles or larvae when seen. Spray along baseboards and edges of rugs and carpeting. Spot spray backing of rugs and carpets and allow to dry thoroughly before replacing on floor. Also, treat under furniture, in closets (baseboards and shelving), and wherever larvae are suspected.

To Kill Brown Dog Ticks and Fleas: For use in Kennels. Thoroughly apply as a spot treatment to infested areas such as animal beds and resting quarters; nearby cracks and crevices; along and behind baseboards, window and door frames; and localized areas of floor and floor coverings where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment. DO NOT SPRAY PETS WITH THIS PRODUCT. To control the source of flea infestations, treat your pet with a product registered for animal application. Also, treat your yard with a product registered for yard application.

FOR CRACK AND CREVICE:

To Kill Ants (excluding fire, harvester and pharaoh ants), German Roach, Crickets, Silverfish, Sowbugs, Spiders (including Black Widow Spiders but excluding Brown Recluse Spiders), Brown Dog Ticks, Fleas, and Carpet Beetles: Apply spray in small amounts directly into cracks, and crevices; in points between different elements of construction; between equipment, floors, and openings leading to voids; into hollow spaces in walls; and on equipment legs and bases where the above listed insects hide.

Do not allow product to be deposited onto exposed surfaces or introduced into the air. Do not contaminate food or food processing surfaces.

Building Perimeter Treatment: To help prevent infestations of buildings by Ants (excluding fire, harvester and pharaoh ants), Crickets, Spide (including Black Widow Spiders but excluding brown recluse spiders), Firebrats, Millipedes, Pillbugs and Sowbugs, treat a 12 – 18 inch band of soil or others ubstrate adjacent to buildings and the building foundation to a height of 2 to 3 feet where these pests are active and may find entrance. Keep pets and children out of the treated area until the spray has dried.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Pesticide Storage
