The MGK Roach Trap has a house-like shape and comes with an attractant which lures the cockroach inside the trap where they are caught by a special adhesive surface. Once trapped, the cockroach will not escape due to the strong adhesive. Under opened condition, the adhesive remains sticky for approximately one month.

The MGK Roach Trap can be used both as a monitoring device and as a control treatment when used at sufficiently high densities. FOR MONITORING: Place traps at a density of 1-2 per 100 sq. ft. FOR COCKROACH CONTROL: Place traps at a density of 3-5 per 100 sq. ft.

Instructions:

- · Peel off the paper covering the sticky surface.
- Remove the attractant tablet from the foil and place it in the center of the adhesive-coated surface. In the event of contact with skin or clothing, the adhesive can be removed with household cleaners.
- · Close the trap to form a "mini-house" shape.
- · Do not place traps in areas accessible to children or pets.
- Place the traps in any dark or humid area where cockroaches and other crawling insects are usually found (near plumbing; under and behind sinks; in corners and cracks; behind refrigerators, stoves, dishwashers, etc.; in bathrooms; around laundry machines; in refuse storage areas; etc.). Avoid direct sunlight.
- Do not allow children or pets to play with traps.
- When trap is fitted with cockroaches, fold it up, wrap in newspaper, and discard in trash.
- · Place out new traps as described above.
