As you indicated in your September 19, 2000 submission, when the labels for the above noted products were drafted (for the initial submission, the names of the products were switched on the labels. This error was furthered on January 17, 2000 when you sent in an amendment to correct the active concentration and use directions on the labels, not realizing that the labels themselves needed to be switched "back". You have stipulated in your letter (9/19/00) that no product under either label has been sold however, as you are now interesting in providing these products to customers, you would like to have the original error corrected.

In response, we have corrected the labeling for these two products. You will note that the products and their respective names/EPA Reg. No's are given above. The correct labeling has been placed in the appropriate files.
