

Use on Lawns: Bent, Bermuda, Bluegrass, Dichondra, Fescue, Irish Moss, Merion and St. Augustine

Pests: Ants Armyworms, Brown dog ticks, Chinch bugs, Crickets, Cutworms, Deer ticks, Fleas, Grasshoppers, Japanese beetle grubs, Mole crickets and Sod webworms. ## Peaches:

Pests: Borers (lesser peachtree, Peach twig), Brown Marmorated Stink Bugs (BMSB), Green fruitworms, Plum curculio, Oriental fruit moths Tarnished plant bugs, Stink Bugs. How to Use: Do not apply within 7 days of harvest. Do not make more than 8 applications per season.

Pears:

Pests: Codling moth, Green fruitworms, Pear psylla.

How to Use: Do not make more than 3 applications per season. Can be applied up to 14 days prior to harvest.

Use on Vegetables: Asparagus (pre-harvest), Asparagus (post-Harvest), Celery and Cole Crops (Broccoli, Brussels Sprouts, Cabbage, Caulițiower), Cucumber, Melons, Pumpkins, Squash, Cucurbits, Eggplant, Horseradish, Head Lettuce, Leafy Vegetables, Potatoes, Peppers, Spinach, Sweet Cero, Tematoes.

## Pests: Asparagus beetles, cutworms

How to Use: Use 1.5 fl. oz. in one gallon of water to cover 1,000-sq. ft. Apply for uniform coverage as needed. Do not make more than 4 applications per crop Can be applied up to 3 days prior to harvest.

## Asparagus (post-harvest):

Pests: Beetles (Adult Japanese Beetle, Larval stages of Asparagus Beetle), Lygus bugs, Tarnished plant bugs.

How to Use: Use 1.5 fl. oz. in 1 gallon of water to cover 1,000 sq. ft. Treat ferns or bush growth after spear harvest when insects are present.

### Celery:

Pests: Armyworms (beet, Fall, Southern), Cabbage loopers, Cutworms (black, granulate), Vegetable leafminers. How to Use: Use 1.5 fl. oz. in 1 gallon of water to cover 1,000 sq. ft. Apply every 3-5 days or as needed. Can be applied up to 3 days prior to harvest. Do not make more than 10 applications per season.

## Cole Crops: Broccoli, Brussels Sprouts, Cabbage, and Cauliflower.

Pests: Beet armyworms, cabbage aphids and cabbage loopers, Diamondback moths, Imported cabbageworms.

How to Use: Use 1 fl. oz. in 1 gallon of water to cover 1,000-sq. ft. Apply every 5 days or as needed. Can be applied up to 1 day prior to harvest. Do not make more than 8 applications on Cauliflower, Brussels Sprouts, and Broccoli and 10 applications on Cabbage.

## Cucumber, Melons, Pumpkins, Squash:

Pests: Flea Beetle, Leafhopper

How to Use: Use 2 fl. oz. in 1 gallon of water to cover 1,000 sq. ft. Apply as needed but not more than 8 applications per season. Can be applied up to day of harvest.

Cucurbits: Balsam Pear (Bitter Melon), Chinese Waxgourd (Chinese Preserving Melon), Citron Melon, Cucumber, Gherkin, Edible Gourds, Melons including hybrids such as Cantaloupe, Casaba, Crenshaw, Honeydew, Honey Balls, Mango Melon, Muskmelon, Persian Melon,

### Pumpkin, Summer & Winter Squash, Watermelon.

Pests: Aphids, Cabbage Looper, Cucumber Beetle (adults), Cutworms, Leafhoppers, Leafminers, Melonworms, Pickleworm, Plant Bugs, Squash Bugs. How to Use: Use 2 fl. oz. in 1 gallon of water to cover 1,000 sq. ft. Apply as needed to ensure uniform coverage. Do not exceed 8 applications per season. Can be applied up to the day of harvest.

#### Eggplant:

Pests: Brown Marmorated Stink Bugs (BMSB), Colorado Potato beetles, Stink Bugs, Vegetable leafminers. How to Use: Use 3 fl. oz. in 1 gallon of water to cover 1,000-sq. ft. Apply for uniform coverage as needed. Do not exceed 16 applications. Can be applied up to 3 days prior to harvest.

## Horseradish (Foliar Application):

## Pests: Imported crucifer weevils

How to Use: Use 3 fl. oz. in 1 gallon of water to cover 1,000-sq. ft. Apply as needed. Do not exceed 3 foliar applications. Can be applied up to 22 days prior to harvest.

Head Lettuce:

Pests: Corn earworms, Beet armyworms, Loopers (Alfalfa, Cabbage), Tobacco budworms How to Use: Use 2 fl.oz. in 1 gallon of water to cover 1,000 sq. ft. Apply every 5-10 days as needed. Do not make more than 10 applications per season. Can be applied up to 1 day prior to harvest.


