#### **IAPPLICATION INSTRUCTIONS:**

Apply 1/2 fluid ounce per 100 pounds body weight of animal, up to a maximum of 5 fluid ounces for any one animal to kill Lice Horn Flies and Face Flies. Aids in insecticidal control of Horse Flies, Stable Flies, Mosquitoes, and Black Flies on lactating and non-lactating dairy cattle, beef cattle, calves, and sheep. For sheep, apply 1/4 fluid ounce per 50 pounds body weight of animal, up to a maximum of 3 fluid ounces for any one animal. Pour-On: Pour along back line and down face. # STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

#### Pesticide Storage

Store in a cool, dry (preferably locked) place in an area that is inaccessible to children and animals. Always store pesticides in the original container. Store away from food, pet food and feed.

#### Pesticide Disposal

To avoid wastes, use all material in this container by application according to label directions. If wastes cannot be avoided, offer remaining product to a waste disposal facility or pesticide disposal program (often such programs are run by state or local governments or by industry).

### Container Disposal

Nonrefillable container. Do not reuse or refill this container.

# [For Containers of 5 Gallons (18.9 L) or Less]

Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.
