Apply spray to pests flushed out.

<u>For Control of Stored Product Pests</u>: (Saw-toothed Grain Beetles, Confused Flour Beetles, and Rice Weevils). In the home kitchen, remove and inspect stored food products. Remove infested packages and seal in plastic bag to prevent reinfestation. Discard bag in garbage. After removing all food packages and shelf liner, spray visible pests and cracks, crevices, and corners of pantries, cupboards, and storage areas. Allow treated areas to dry and then install new shelf liner and return containers to shelves. Repeat treatment as necessary, but not more frequently than once every 2 weeks.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

Store in a cool, dry area. Always store pesticides in the original container. Store away from food and pet food.
