Do not use in commercial food/feed handling establishments or restaurants or other areas/sites where food/feed is commercially prepared or processed. In the home cover all food processing surfaces and utensils during treatment or thoroughly wash before use following treatment. Cover or remove exposed food.

SHAKE WELL BEFORE USE. HOLD CONTAINER UPRIGHT. APPLY IN SHORT BURSTS.

INDOORS:

AS A SPACE SPRAY:

TO KILL FLIES, GNATS, MOSQUITOES, SMALL FLYING MOTHS, AND YELLOW JACKETS: Before spraying cover exposed food and utensils. Close all doors and windows and direct spray upward into center of room with slow sweeping motion. Spray 5-10 seconds for average room. Keep room closed for 15 minutes after spraying. Sweep up and destroy fallen insects.

FOR SPOT TREATMENT:

TO KILL ANTS, CENTIPEDES, COCKROACHES, CRICKETS, FIREBRATS, SOWBUGS AND SPIDERS: Thoroughly spray all parts of the room suspected of harboring these pests. Directly spray as many insects as possible. Pay special attention to cracks, hidden surfaces under sinks, behind stoves and refrigerators, in food storage areas and wherever these pests are suspected of hiding. To kill ants, treat doors, around window frames, ant trails and other areas of entry. Repeat after five weeks for control.

TO KILL CARPET BEETLES: Directly spray as many insects as possible. Spray both interior and exterior of upholstered furniture. Thoroughly spray both top and bottom of rugs and carpets. Also, treat shelves, closets, areas under furniture, and wherever these insects are seen or suspected.

TO KILL EXPOSED FORMS OF CONFUSED FLOUR BEETLES, RICE WEEVILS, AND SAW-TOOTHED GRAIN BEETLES: Find and destroy infested package goods. Remove all other items from pantry. Spray the shelves to kill any of the named insects present. Place clean paper on the shelves and return packages after shelves have dried.

TO KILL FLEAS AND TICKS IN PET BEDDING AND PET AREAS: Remove and destroy pet's old bedding before treatment. To reduce infestation, thoroughly spray the animal's sleeping quarters, around baseboards, window and door frames, wall cracks, local areas of floors, and other resting places until the surface is slightly moist. Treat these areas at the rate of two seconds per linear foot at a distance of 12 to 18 inches. Also, spray the entire inside surface of doghouses. Place fresh bedding in pet's quarters after spray is dry. DO NOT SPRAY PETS WITH THIS PRODUCT. Treat pet with a pesticide product registered for use on animals at the same time that the house and yard are treated.

TO TREAT FLEA AND TICK INFESTATION IN RUGS AND CARPETS: Spray rugs and carpets where fleas tend to hide. If used on light or delicate upholstery fabrics, test for potential staining in an inconspicuous place prior to use. Thoroughly spray into hiding places such as cracks and crevices, in walls and floors, along baseboards, window and door frames. Spray at the rate of one square foot per second.

OUTDOORS:

TO CONTROL FLIES AND MOSQUITOES: Use only outdoors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames as well as other areas where these pests may enter the home. In addition, spray dark corners and localized resting areas (such as under eaves), porches, patios, and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Spray only when the air is still. Allow spray to dissipate before occupying the treated area.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

<u>STORAGE</u>: Pesticide Storage Store in a secure, preferably locked storage area away from heat or open flame. Store in a cool, dry area, Always store pesticides in the original container. Store away from food and pet food.
