<u>IMPORTANT NOTE</u>: Plant safety is an important consideration when using insecticides in a greenhouse. However, it is not possible to evaluate the phytotoxicity of PyGanic® Crop Protection EC 1.4_{II} on numerous plant varieties that may react differently to insecticides in different growth stages or under varying environmental conditions. This wording allows the use of PyGanic® Crop Protection EC 1.4_{II} on crops that may not be specifically listed on this label (providing that the group to which the crop belongs is listed).

<u>USE ON GREENHOUSE FRUIT, VEGETABLE, FLOWER AND FOLIAGE PLANTS</u>: Used alone: Combine 16 ounces (1 pint) (456 g) to 32 ounces (1 quart) (907.18 g) with 30 gallons (113.4L) of water for applications with conventional hydraulic sprayers or 1 to 2 ounces per gallon (7.5 g to 15 g/L) of water for applications with compressed sprayers.

FOR USE OUTDOORS ON TREES, SHRUBS, FLOWERS AND FOLIAGE PLANTS:

Used alone: Combine 3.5 to 7 pints (1656 ml to 3312ml) of PyGanic® Crop Protection EC 1.4_{II} with 100 gallons (378L) of water for applications with conventional hydraulic and airblast sprayers or 3.5 to 7 pints (1,656 ml to 3,312ml) of PyGanic® Crop Protection EC 1.4_{II} with 10 gallons (37.8L) of water for applications with low volume mist blowers or 1 to 2 fl. oz. per gallon (7.93 ml to 15.86 ml/L) water for applications with compressed air sprayers.

FOR USE AROUND THE EXTERIOR OF HOMES AND OTHER BUILDINGS: To control insects on Turf, Ornamental Plants, Gardens, Landscaping, Foundation Walls and Perimeters mix 1 to 2 fl. oz. of PyGanic® Crop Protection EC 1.4_{II} per gallon (7.93 ml to 15.86 ml/L) of water for applications with compressed air sprayers or pump driven sprayers.

USE INDOORS ON TREES, SHRUBS, FLOWERS AND FOLIAGE PLANTS:

<u>USED ALONE</u>: Combine 3.5 to 7 pints (1,656 ml to 3,312 ml) of PyGanic® Crop Protection EC 1.4_{II} with 100 gallons (378 L)of water for applications with conventional hydraulic sprayers or 1 to 2 fl. oz. of PyGanic® Crop Protection EC 1.4_{II} per gallon (7.93 ml to 15.86 ml/L) of water for applications with compressed air sprayers.

USE WITH HYDROPONICALLY GROWN VEGETABLES AND ORNAMENTALS

AS A WATER SYSTEM TREATMENT: To control aquatic diptera larvae, apply PyGanic® Crop Protection EC 1.4_{II} to the water at the rates outlined in the following table:

FOR USE ON HARVESTED FRUITS AND VEGETABLES: Including apples, blackberries, blueberries, boysenberries, cherries, crabapples, currants, dewberries, figs, gooseberries, grapes, guavas, loganberries, mangoes, muskmelons, oranges, peaches, pears, peas, pineapples, plums, raspberries, tomatoes.

DIRECT SPRAY TO FRUITS IN BASKETS, ON TRUCKS OR IN PROCESSING PLANTS: To control Drosophila spp., Tephritid spp. fruit flies, Vinegar Flies and other nuisance pests dilute this concentrate at the rate of 1 part with 250 parts water (1 pint with 32 gallons (4 ml/L) or 1 teaspoon with 2.5 pints (1,182 L) water). Thoroughly mix the emulsion in the spray tank and treat as follows:

- 1) Apply liberally to fruits and vegetables in baskets, on trucks and in plants. Use sprayers at a high pressure for applying at the rate of five or six pints (2.36 to 2.84L) of diluted spray to a 2 ton load of produce. Direct the spray for maximum coverage of the baskets or hampers. It is important to spray between and beneath the containers.

Use 1 gallon of the spray per 750 square feet (54 ml/m²), directing it on walls, ceiling, and floors paying special attention to forcing the spray into all cracks and crevices for the control of ants, roaches, silverfish, crickets, spiders and cheese mites. Use one ounce diluted spray per 1000 cubic feet of space (1g/m³). Do not spray while the plant is in operation as dead flies may fall into containers or the products being processed.

AS A SPACE SPRAY IN FOOD AND NONFOOD AREAS OF FOOD PROCESSING PLANTS, INDUSTRIAL INSTALLATION, BAKERIES, RICE AND WHEAT MILLS, RESTAURANTS, TOBACCO WAREHOUSE, GRAIN ELEVATORS, HOMES, RESTAURANTS SUPERMARKETS, WAREHOUSES AND WINERIES: To kill flying insects such as fruit flies, house flies, hornets, wasps, grain moths, gnats, mosquitoes and skipper flies, dilute this concentrate at the rate of 1 part to 2 parts water (2 quarts with one gallon (3.78L) of water). Use at the rate of 1 oz. of diluted spray per 1000 cubic feet (1g/m³) of space. Direct the space treatment upward and whenever practical, keep doors and windows closed for at least 30 minutes after application. The use of this product in food processing or food handling establishments should be confined to time periods when the plant is not in operation. Food should be removed or covered during treatments. All food processing surfaces should be covered during treatment or thoroughly cleaned before use. <u>CRAWLING AND FLYING INSECTS</u>: For control of accessible, exposed stages of CRAWLING INSECTS including but not limited to, Ants, Cockroaches, Cadelles, Cigarette Beetles, Confused Flour Beetles, Dark Mealworms, Dried Fruit Beetles, Drugstore Beetles, Grain Mites, Red Flour Beetles, Rice Weevils, Sawtoothed Grain Beetles, Spider Beetles, Yellow Mealworms and FLYING INSECTS including, but not limited to, Angoumois Grain Moths, Cheese Skippers, Fruit Flies, Fungus Gnats, Gnats, House Flies, Indian Meal Moths, Mosquitoes, Mediterranean Flour Moths, Small Flying Moths, Tobacco Moths, dilute 1 part of PyGanic® Crop Protection EC 1.4_{II} with 2 parts of water or oil (2 quarts with one gallon (3.78L) of water or oil) and apply at the rate of 1 ounce per 1,000 cubic feet (1g/m³) of space. Direct the spray towards the ceiling and upper corners of the area and behind obstructions. Vacate the treated area and keep the area closed for at least 30 minutes after treatment. Ventilate the area before reoccupying.

<u>USE AS A SURFACE SPRAY IN HOMES, RESTAURANTS, FOOD PROCESSING PLANTS, INDUSTRIAL INSTALLATIONS, SUPERMARKETS,</u> <u>WAREHOUSES AND WINERIES</u>: to control accessible, exposed stages of crawling insects including, but not limited to, Ants, Cockroaches, Cadelles, Cigarette Beetles, Confused Flour Beetles, Dark Mealworms, Dried Fruit Beetles, Drugstore Beetles, Grain Mites, Red Flour Beetles, Rice Weevils, Sawtoothed Grain Beetles, Spider Beetles, Yellow Mealworms, dilute 1 part PyGanic® Crop Protection EC 1.4_{II} with 12 parts water (11 fl. oz. with one gallon of water(87.23 ml/L)) and apply at the rate of 1 gallon to 750 square feet (54ml/m²), paying special attention to force the spray into all cracks and crevices.

Except in Federally inspected meat and poultry plants, food processing operations may continue when this product is applied as a surface spray with care and in accordance with the directions and precautions given above.

<u>FOR USDA INSPECTED FACILITIES</u>: To control accessible, exposed stages of crawling insects including, but not limited to, ants, cockroaches, cadelles, cigarette beetles, confused flour beetles, dark mealworms, dried fruit beetles, drugstore beetles, grain mites, red flour beetles, rice weevils, sawtoothed grain beetles, spider beetles, yellow mealworms, dilute 1 part PyGanic® Crop Protection EC 1.4_{II} with 4 parts of water (1 quart with one gallon of water) and apply at the rate of 1 gallon to 750 square feet (54ml/m²), paying special attention to force the spray into all cracks and crevices.

FOR USE ON SWEET POTATOES IN STORAGE: For control of Fruit Flies and Vinegar Flies dilute this concentrate at 1 part to 4 parts water (1 quart with one gallon (3.78 L) of carrier). Apply as a space fog with a mechanical fogger capable of producing particles of aerosol size at the rate of 1 gallon diluted spray per 100,000 cubic feet of space (1.3 ml/m³). Apply only when flying insects are present. Several applications may be necessary during period of heavy infestation, but do not make more than 10 applications

FOR USE ON STORED PRODUCTS: This concentrate can be used at the rate of 1 part to 2 parts water or acceptable carrier (2 quarts with one gallon (3.78L) of water or acceptable carrier) can be used on rice, barley, beans, birdseed, buckwheat, cocoa beans, corn, cottonseed, flax, oats, grain nuts, dried fruit, almond nutmeat and shells, walnut nutmeat and shells, pistachio, dried prunes, dried apricots, raisins, figs, wheat, oats, corn, barley, rye, sorghum, wheat, tobacco and peanuts held in storage for control of the accessible stages of Almond Moths, Angoumois Grain Moths, Cadelle Beetles, Cigarette Beetle, Confused Flour Beetles, Flat Grain Beetles, Granary Weevils, Indian Meal Moths, Red Flour Beetles, Rice Weevils, Rusty Grain Beetles, Sawtoothed Grain Beetles, Square Necked Grain Beetles, and Tobacco Moths.

<u>SURFACE TREATMENT OF STORED GRAIN AND SEED</u>: To control Indian Meal Moths, Angoumois Grain Moths and Mediterranean Flour Moth, monthly inspections should be made after the grain is placed in storage. If the top two or three inches are infested, dilute 1 part PyGanic® Crop Protection EC 1.4_{II} with 4 parts of water (1 quart with one gallon (3.78L) of water) and apply at the rate of 2 gallons per 1,000 square feet (80 ml/m²) of grain. Rake the mixture into the grain to a depth of 4 inches (10.16 cm).

<u>FOR USE AS A GRAIN PROTECTANT</u>: This concentrate when diluted with water and sprayed directly on grains will effectively protect the grain against grain storage insects for a full season or approximately 8 months. Dilute at the rate of 1 part to 6 parts water (1.3 pints with 1.0 gallon of water (16 ml/L)). Thoroughly mix the emulsion and apply at the rate of 5 gallons (18.9L) per 1000 bushels of grain as it is carried along a belt or as it enters the auger or elevator. This concentrate may be used in combination with a registered fumigant for use on heavily infested stored products

Monthly inspections should be made. If the top 2 or 3 inches (5.08 cm to 7.2 cm) are found to be infested, re-treat applying at the rate of 1 to 2 gallons (3.78L to 7.56L) of diluted material per 1000 bushels of stored product.

<u>ON ALMONDS, PEANUTS AND WALNUTS IN BULK OR IN BAGS</u>: To control stored product insects including, but not limited to: Almond Moths, Angoumois Grain Moths, Ants, Cadelles, Cigarette Beetles, Confused Flour Beetles, Drugstore Beetles, Flat Grain Beetles, Granary Weevils, Indian Meal Moths, Lesser Grain Borers, Maize Weevils, Mediterranean Flour Moths, Merchant Grain Beetles, Red Flour Beetles, Rice Weevils, Rusty Grain Beetles, Sawtoothed Grain Beetles and Squarenecked Grain Beetles, dilute 7 ounces of PyGanic® Crop Protection EC 1.4_{II} per gallon of water and apply as a coarse wet spray over the top of stored nuts or the outside surface of stacked bagged nuts at the rate of 4 gallons per 1,000 square feet (160 ml/m²). Apply at weekly intervals for about 6 weeks and then at 15 day intervals. The first two applications should be applied at the rate of 4 gallons per 1,000 square feet (160 ml/m²) and subsequent treatments should be applied at the rate of 2 gallons per 1,000 square feet (80 ml/m²).

<u>FOR USE IN STORAGE SITES</u>: This concentrate can be used to treat grain and seed in warehouse bins and trucks, cargo ships, mills, bin hoppers, elevators and conveying equipment as a clean up prior to using them for storage. In mills and elevators, all grain infested accumulations should be removed from the bin hoppers. All storage areas and conveying equipment should be thoroughly cleaned by sweeping out the waste grain, cobwebs and other debris from the walls and rafters as well as on the floor and door frames with special attention to material lodged in the cracks and crevices. All of the debris should be removed and burned to kill eggs and insects that might be present.

For farms, particular attention should be given to cleaning up around the used feed and grain bags, grain residues from wagons, harvesting equipment and feed troughs. Newly harvested grain should not be placed in the same bin with carry-over grain and all carry-over grain stocks that are not treated with grain protectant should be fumigated. These cleaning operations should be done within two or three weeks before harvest.

After above sanitation measures have been employed, spray all areas prior to use for storage with 1 part to 6 parts water (1.3 pints with 1.0 gallon of water (16ml/L)) up to 1 part to 2 parts (1 quart with 1 gallon of water (3.78L)). Apply at the rate of one gallon per 750 square feet (54ml/L) on walls, floors, ceilings and partition boards of bins, paying particular attention to forcing the spray into all cracks and crevices.

FOR USE AS A LIVESTOCK AND POULTRY SPRAY:

- To kill and repel horn flies, house flies, mosquitoes and gnats, dilute at the rate of 5 to 10 fluid ounces per gallon (39.65ml to 79.3ml/L)of water and apply to wet the hair thoroughly with particular attention to topline, underline, flanks, withers and other infested areas. Repeat treatment at intervals of 5 to 12 days for small insect populations or as needed when flies are emerging in large numbers.
- 2) To kill and repel stable flies, horse flies, and deer flies, dilute at the rate of 9 to 14 fluid ounces per gallon (71.37 ml to 111.02 ml/L) of water and apply a quart per adult animal to wet the hair thoroughly with particular attention to the legs, flanks, barrel, topline and other body areas commonly attacked by these flies. Repeat treatment each week as needed.
- 3) To kill and repel face flies dilute at the rate of 9 fluid ounces per gallon (71.37 ml/L)of water and apply using spray which produces large wetting droplets. Apply to the face of the animal in the morning before releasing to pasture. Apply sufficiently to wet the face but not more than 1-1/2 ounces (14.17 g to 28.35g) of diluted solution per animal. Repeat daily as needed.
- 4) For effective control of biting and sucking lice on cattle, horses, sheep, goats and hogs, dilute at the rate of 1 quart with 16 gallons of water (3 fluid ounces with 1 gallon (23.79 ml/L)) and spray to thoroughly wet the hair of the animal including the head and brush of the tail. Repeat treatment in 10 days to kill newly hatched lice.
- 5) To control poultry lice, using a dilution of 9 to 14 ounces of concentrate per gallon (71.37 ml to 111.02 ml/L) of water spray roosts, walls and nests or cages thoroughly. It is not necessary to remove poultry from the housing unit during treatment. This should be followed by spraying over the birds with a fine mist.
- 6) For control of bedbugs and mites on poultry and in poultry houses, dilute at the rate of 9 to 14 fluid ounces per gallon (71.37 ml to 111.02 ml/L) of water and spray crevices of roost poles, cracks in walls and cracks in nests where the bedbugs and mites hide. This should be followed by spraying over the birds with a fine mist.
- 7) To control sheep "tick" or ked, dilute at the rate of 5 to 10 fluid ounces per 4 gallons (9.78 ml to 19.56 ml/L)of water and thoroughly wet all portions of the body by dipping or by spraying with sufficient pressure and with a nozzle adjustment to give penetration of the wool. Treat at a rate sufficient to wet the animal.
- 8) To kill fleas and ticks on livestock and to obtain protection against reinfestation, dilute at the rate of 9 fluid ounces per gallon (71.37 ml/L) of water and wet the animal by dipping or spraying. This product may also be used for livestock/pet quarters. Do not spray pets. For best results against fleas and ticks on dogs and cats the kennels and/or animal quarters and bedding should be treated. Remove and destroy pet's old bedding. To reduce infestation, thoroughly spray the animal's bedding and sleeping quarters. Also spray the entire inside surface of dog houses. Put fresh bedding in pet's quarters after spray has dried. Also treat dogs and cats [pets] with a registered flea and tick control product before allowing them to reenter treated area.
- 9) To control adult darkling beetle (lesser meal worm) in poultry houses, dilute 1-3 fl. oz. of PyGanic Crop Protection EC 1.4_{II} per gallon (7.93 ml to 23.79 ml/L) of water. Using a power or proportioner-type sprayer, apply a uniform spray until wet at pressures of 80 to 100 pounds per square inch (5.62 Kg to 7.03 Kg/cm²) to surfaces such as interior walls, roosting posts, structural support pillars, and other surfaces where adult beetles are observed. One gallon (3,78L) of spray mixture covers 250-500 sq. ft (23.23- 46.45 m²). Do not contaminate food/feed or water. For maximum effectiveness, treatments should coincide with each growout or sanitation procedure. Indoor control can be enhanced by making perimeter treatments around the outside of buildings. To prevent immigrating adult beetles, apply a uniform band of spray 2 feet (0.6 m) up and 1-4 feet (0.3 1.2m) out from the foundation.

For maximum effectiveness, treatments should coincide with poultry house clean out and litter replacement as this activity will tend to flush beetles to vertical surfaces where they will be exposed to the spray.

FOR USE IN BARNS, DAIRIES, MILKING PARLORS, MILKING ROOMS AND POULTRY HOUSES: To control flying insects including, but not limited to: Flies, Fruit Flies, Mosquitoes, Gnats, Wasps, Hornets and Small flying Moths, dilute at the rate of 9 fluid ounces per gallon (71.37 ml/L) of water. Apply as a fog or fine mist (at approximately 2 ounces per 1000 cubic feet of space (2g/m³), directing the nozzle for maximum coverage and above livestock and poultry toward the ceiling and upper corners of the area being treated. For best results, close doors and windows before spraying, and keep them closed for 10 to 15 minutes. Applicator should vacate the treated area and ventilate it prior to returning.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

PESTICIDE STORAGE:

Store in a cool, dry area under lock and key. Post as a pesticide storage area. Always store pesticides in the original container. Store away from food, feed, seed, fertilizers, and veterinary suppliers. Place formulations on lower shelves and dry formulations above.

PESTICIDE DISPOSAL:

To avoid wates, use all materials in the containers by application according to label directions. If wastes cannot be avoided, offer remaining product to a waste disposal facility or pesticide disposal program (often such programs are run by state local governments or by industry).

LABEL SUPPLEMENT

DIRECTIONS FOR APPLICATION THROUGH IRRIGATION SYSTEMS

Apply this product only through sprinkler (including center pivot, lateral move, end tow, side (wheel) roll, traveler, big gun, solid set, or hand move) irrigation systems. Do not apply this product through any other type of irrigation system.

Crop injury, lack of effectivness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water.

If you have questions about calibration, you should contact State Extension Service specialists, equipment manufacturers or other experts.

Do not connect an irrigation system (including greenhouse systems) used for pesticide application to a public water system unless the pesticide label-prescribed safety devices for public water systems are in place.

A person knowledgeable of the chemigation system and responsible for the operation or under the supervision of the responsible person, shall shut the system down and make necessary adjustments should the need arise.

The system must contain a functional check valve, vacuum relief valve, and low-pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow. The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump. The pesticide injection pipeline must also contain a functional normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump motor stops. The irrigation line or water pump must include a functional pressure valve which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.

Systems must be a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.

Do not apply when wind speed favors drift beyond the area intended for treatment.

Constant agitation must be maintained in the chemical supply tank during the entire period of insecticide application. Greater accuracy in calibration and distribution will be achieved by in NOTIFICATE Volume of more dilute suspension per unit of time.
