#### SHAKE WELL BEFORE USE

Typical areas that may require insecticide treatment:

#### INDOORS:

Spray areas where Asian Lady Beetles, Box Elder Bugs, Brown Marmorated Stink Bugs (BMSB), Cockroaches, Palmetto Bugs, Ants, Clover Mites, Crickets, Firebrats, Water Bugs, Silverfish, Stink Bugs and Spiders are found or normally occur including dark corners of rooms and closets, cracks and crevices in walls, along and behind baseboards, beneath and behind sinks, stoves, refrigerators, and cabinets, and around plumbing and other utility installations.

For control of Ants, apply to ant trails, around doors and windows, and wherever else Ants may find entrance.

For control of Carpet Beetles, thoroughly spray along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets, on shelving, and wherever else insects are seen or suspected.

For control of Fleas and Brown Dog Ticks, thoroughly spray pet beds and resting quarters and nearby cracks and crevices, along and beind baseboards, window and door frames, and localized areas of floors and floor coverings where fleas and ticks may be present. Pet bedding should be replaced with clean fresh bedding after treating the area. Do not treat pets with this product. To control the source of flea infestations, treat pets with a product registered for application to animals.

Note: Check carpet manufacturer's warranty and care and maintenance information before using product on your specific brand of carpoting.

AS A SURFACE SPRAY: Use at a rate of one (1) gallon [96 fluid ounces] [24 fluid ounces] [16 fluid ounces] of spray per 1,000 [750] [188] [125] square feet.

To kill the Accessible Stages of Granary Insects: Rice Weevils, Confused Flour Beetles, Rust Red Flour Beetles, Saw tootiled Grain Beetles, Cadelles, Meal Moth Larvae and Adults, Cigarette Beetles, Drugstore Beetles, and Granary Weevils. Apply as a coarse wet spray to surface where these pests are normally found, such as floors and baseboards and around walls, benches, and pieces of equipment. Pay particular attention to cracks, crevices, and similar protected locations in floors and walls. Thoroughly spray around and into floor drains, non-food conveyors, and other areas where granary insects may be found. Do not apply when food processing facility is in operation or food is exposed. Do not apply this spray to surfaces of utensils that may come into contact with food, excessive food residues may result.

Do not exceed more than one (1) application every fourteen (14) days.

To kill Ants, Asian Lady Beetles, Box Elder Bugs, Brown Marmorated Stink Bugs (BMSB), Cockroaches, Crickets, Earwigs, Millipedes, Psocids, Silverfish, Sowbugs, Spiders, Stink Bugs and Waterbugs: Apply this spray with a sprayer that produces coarse wetting droplets into all cracks and crevices in woodwork and floors, underneath sinks, areas behind pipes, and in all places where these insects shelter. Directly spray as many insects as possible. Do not exceed more than one (1) application every seven (7) days in restaurants and similar food service establishments or more than one (1) application every fourteen (14) days in all types of food handling establishments.

FOR PREMISE PESTS: Use at the rate of one (1) gallon [96 fluid ounces] [24 fluid ounces] [16 fluid ounces] of spray per 1,000 [750] [188] [125] square feet.

Application within residential and non-residential buildings including Homes, Apartment Buildings, Kennels, and Non-Food Areas of Industrial, Institutional, and Commercial Buildings, such as Hospitals, Hotels, Warehouses, Truck Trailers, Railroad Cars, Airplane Cargo Holds, Theatres, Office Buildings, and Schools.

GENERAL: Apply as a coarse wet spray to thoroughly treat hiding places such as cracks and crevices, moist areas around pipes, under refrigerators, and along baseboards to control pests listed below. Use at the rate of one (1) [96 fluid ounces] gallon of spray mixture per 1,000 [750] square feet. Spray directly on insects when possible. Do not permit humans or pets to contact treated surfaces until the spray is dry. Do not treat establishments where livestock feed is present.

To kill Ants, Asian Lady Beetles, Box Elder Bugs, Brown Marmorated Stink Bugs (BMSB), Cockroaches, Crickets, Earwigs, Millipedes, Psocids, Silverfish, Sowbugs, Spiders, Stink Bugs and Waterbugs: Spray areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices in walls, along baseboards and door and window frames, behind and beneath sinks, stoves, refrigerators and cabinets, and around garbage cans, plumbing and other utility installations. Directly spray pests driven out of hiding places. For Ants, apply to ant trails, around doors and windows, and wherever these pests may find entrance.

To kill Brown Dog Ticks and Fleas: For control of Brown Dog Ticks, thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings where these pests may be present. For control of Fleas, thoroughly apply a fine particle broadcast spray to infested rugs, carpets, and pet resting areas. Prior to treatment cover aquariums and fish bowls and remove birds, such as canaries, from the area. Do not permit humans or pets to contact treated surfaces until spray is dry. Following treatment, remove and replace old bedding with clean, fresh bedding. Do not spray pets with this product. Treat dogs and cats with a product registered for use on animals. Also, treat your yard with a product registered for yard application.

To kill Bed Bugs: First, thoroughly clean and air mattresses and springs. Apply as a spot treatment to cracks and crevices, around baseboards, and on floorboards, headboards, and walls. Then spot treat only areas that may harbor pests. On mattresses, concentrate on tufts, folds, and seams.

To kill Carpenter Ants: Use a coarse spray, around doors, door frames, windows, and other areas where Carpenter Ants enter the premises or hide. Spray into cracks and crevices, through openings, or into small newly drilled holes into wall voids where these Ants or their nests are present.

Typical areas that may require insecticide treatment:

OUTDOORS:

Do not water the treated area to the point of runoff.

Do not make applications during rain.

All outdoor applications must be limited to spot or crack-and-crevice treatments only, except for the following permitted uses:

- (1) Treatment to soil or vegetation around structures;
- (2) Applications to lawns, turf, and other vegetation;
- (3) Applications to building foundations, up to a maximum height of 3 feet.

Other than applications to building foundations, all outdoor applications to impervious surfaces such as sidewalks, driveways, patios, porches and structural surfaces (such as windows, doors, and eaves) are limited to spot and crack-and-crevice applications, only.

GENERAL: Use EVERCIDE<sup>®</sup> Esfenvalerate RTU 28062 to control on contact Ants, Asian Lady Beetles, Box Elder Bugs, Brown Marmorated Stink Bugs (BMSB), Cockroaches, Crickets, Sowbugs, Spiders, Stink Bugs and Ticks. Apply to outside surfaces of buildings, porches, patios, garages, grasses, and other areas where these pests are seen or found. Do not spray in or near fish ponds or other bodies of water. Ants, Asian Lady Beetles, Brown Marmorated Stink Bugs (BMSB), Ticks (including ticks which transmit Lyme disease), Crokets, Fleas, Stink Bugs, and Earwigs: For treatment of infestation of these insects in areas where there are weeds or bushy non-crop areas, thoroughly spray infested areas. When treating for ticks, pay special attention to areas frequented by pets. For Ants, thoroughly wet hills and runways.

Building Perimeter Treatment: To help prevent infestations of buildings by Ants, Asian Lady Beetles, Box Elder Buys, Brown Marmorated Stink Bugs (BMSB), Crickets, Spiders, Stink Bugs and Sowbugs (Pillbugs), treat a 12–18 inch band of soil or other substrate adjacent to buildings and the building foundation to a height of 2 to 3 feet where these pests are active and may find entrance.

Keep pets and children out of the treated area until the spray has dried. Do not spray animals. Dogs and cats and their kennel or beddirig area should also be treated with a registered flea control product in conjunction with this application.
