1. Spray at sunrise or sunset when insects are least active.
2. Stand a safe distance from the nest. Do not stand directly underneath.
3. Shake can well before each use. Hold can upright and spray away from person. Push button to spray.
4. Aim actuator at the opening in the nest and spray until soaked.
5. Then spray the rest of the nest until it is saturated. This product's powerful spray will also kill insects that return to the nest.
6. Wait at least 24 hours before removing the nest.

To kill Wasps, Hornets, Yellowjackets, Spiders (including Black Widow Spiders), Crickets, Ants, Fleas, Ticks, Centipedes, Earwigs, Flies and Mosquitoes:

1. Spray 1-2 seconds until surface is moist to kill insects under eaves, around screens, windows, doors, patios, cracks, holes and crevices or wherever insects are noticed.
2. To prevent insects from entering the home, spray around areas where insects enter such as outdoor plumbing, faucets, etc. and cracks or crevices in foundations as well as along sills and ledges.
