It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

READ ALL DIRECTIONS COMPLETELY BEFORE USE

Remove pets, birds, and cover fish aquariums before spraying.

Do not allow children or pets into the treated area until dry.

Do not apply this product in occupied patient rooms or in any rooms/areas while occupied by patients, the elderly or infirm. Do not apply in classrooms when in use. Do not apply to institutions (including libraries, sports facilities, etc.,) in the immediate area when occupants are present. Do not use in serving areas while food is exposed or facility is in operation. Serving areas are the areas where prepared foods are served such as dining rooms but "cluding areas where food may be prepared or held. In the home, all food processing surfaces and utensils should be covered during treatment or

oroughly washed before use. Exposed food should be covered or removed.

Non food/feed areas where this product can be applied are areas such as garbage rooms, lavatories, floor drains (to sewers), offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling).

Hold container upright. Do not spray in air. Turn tip to proper setting, (broad) (fine) spray for surfaces or pinstream for cracks and crevices. Hold approximately 12 inches from surface to be sprayed. Squeeze trigger to spray until surface is slightly moist but not to the point of runoff. [Do not operate in OFF position.] [After use, turn tip to OFF to avoid accidental spraying.]

For best results, follow directions for specific use areas. Do not use this product in or on electrical equipment due to possibility of shock hazard. Do not use on animals. Avoid excessively wetting furniture and carpeting. Always test in an inconspicuous [hidden] area prior to use as some natural and synthetic fibers may be adversely affected by any liquid product.

General: Use this spray as a spot or crack and crevice treatment to control cockroaches, fleas, silverfish, ticks, waterbugs, and other insects listed below. Apply this product only as a coarse spray or crack and crevice treatment to localized areas where pests are found or may occur. Spray surfaces until wet but not to the point of runoff.

To Kill Ants, Black Widow Spiders, Carpet Beetles, Cockroaches, Crickets, Scorpions, Silverfish, Sowbugs, and Spiders:

<u>CRACK AND CREVICE SPRAY</u>: (Use a pinstream spray) Special attention should be paid to areas such as behind baseboards, connection areas around drains, pipes, behind and beneath sinks, stoves, plumbing and other visible cracks and crevices. Spray these areas thoroughly being certain that spray penetrates well.

<u>CONTACT APPLICATION:</u> (A [broad] [fine] spray pattern should be used on all surfaces). Spray at the rate of 1pint [16 fluid ounces] per 125 square feet [1 fluid ounce per 8 square feet] and contact as many insects as possible with this spray in addition to thorough spraying of all parts of the room suspected of harboring these pests. Special attention should be paid to hiding places such as beneath sinks, behind and beneath stoves and refrigerators, around garbage cans, cabinets, along the outside of baseboards, door sills, frames and floors, around and on drains, pipes, plumbing, behind bookcases, storage and other utility installation areas, contacting insects with spray whenever possible. Retreat 30 days after first application.

EXPOSED STAGES OF Flour Beetles, Cadelles, Rice Weevils, Flat Grain Beetles, Cigarette Beetle, Confused Flour Beetle, Drugstore Beetle, Lesser Grain Borer, Merchant Grain Beetle, Sawtoothed Grain Beetle, Grain Weevils, Warehouse Beetle, Red Flour Beetle, Grain Mites and Cheesemites. Find and dispose of infested packaged goods. Remove all other items from pantry, shelves and drawers and clean thoroughly. Spray into cracks, cre ices and areas where these insects tend to congregate. Place clean paper on the shelves and drawers and return packages after the spray has dried.

<u>Carpet Beetles [Dermestids (Trogoderna)]</u>: Directly spray as many insects as possible. Where possible, bottom of rugs and carpets should be sprayed thoroughly. Also treat shelves, closets, areas under furniture, floors, walls, window sills, baseboards and wherever these insects are seen or suspected. Backing of carpets and rugs should be allowed to dry before re-laying on floor.

<u>To Kill Ticks and Fleas</u>: Thoroughly spray as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings where these pests may be present. Pet's old bedding should be removed and replaced with clean, fresh bedding after treatment. DO NOT SPRAY PETS WITH THIS PRODUCT. Pets should be treated with a registered flea and tick control product prior to reentering treated areas. Also, treat your yard with a product registered for yard application.

<u>Fires and Mosquitoes</u>: Use only outdoors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames as well as other areas where these pests may enter the home. Also spray dark corners and localized resting areas (such as under eaves) or porches, patios, and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Retreat every two weeks. Remove all exposed food or cooking utensils. Cover all food handling surfaces or wash thoroughly after treatment and before use. Do not use on edible crops.

Foraging Ants, and Foraging Carpenter Ants:

To kill foraging Ants including Carpenter Ants spray insects directly and ant trails.
