This sentence is inappropriate for this product type and the use directions on the label. We have deleted the sentence "Remove pets, birds and cover fish aquariums before spraying." That sentence is appropriate for an indoor fogging concentrate but inappropriate for an outdoor mosquito adulticide product.
