By Notification, we are updating the storage and disposal statement per PR-Notice 2004-7. Enclosed are two (2) copies of the label. One (1) copy has changes highlighted.

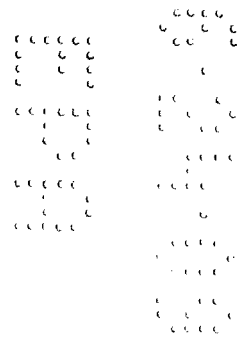
