- c. On the front panel delete Dry fog or substantiate the claim with data. Also delete Fog reaches areas normal foggers cannot reach. False or misleading comparisons with other pesticides are not acceptable.
- d. In the ingredient statement following permethrin add related compounds ... 0.035%. Adjust the Other Ingredients amount accordingly.
- e. Under Directions for Use delete \$\mathbb{\mathbb{Z}}\$Use additional units for remote rooms or where free flow is not assured. This statement conflicts with the statement Do not use more than one fogger per room.
- 3. please submit a one year storage stability and corrosive characteristics study for this product.
- 4. Submit two (2) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

PHYSICAL OR CHEMICAL HAZARDS

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

SHAKE WELL BEFORE USE. KEEP CONTAINER UPRIGHT.

Do not apply directly to food. Do not use in food/feed areas of food/feed handling establishments, restaurants or other areas where food/feed is commercially prepared or processed. Do not use in serving areas while food is exposed or facility is in operation. Serving areas are areas where prepared foods are served such as dining rooms, but excluding areas where foods may be prepared or held. In the home, all food processing surfaces and utensits should be covered during treatment or thoroughly washed before use. Exposed food should be covered or removed. Non-food areas are areas such as garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling).

Remove pets, birds, and cover fish aquariums before spraying.

DO NOT use more than one fogger per room. DO NOT use in small, enclosed spaces such as closets, cabinets or under counters or tables. Do not use in a room 5 ft. X 5 ft. or smaller; instead, allow fog to enter from other rooms.

Cover exposed food, dishes and food-handling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Close doors and windows. Point valve opening away from face and eyes when releasing. Use one unit for each 6,000 [5,000] [4,000] [3,000] cubic feet of unobstructed area. Use additional units for remote rooms or where free flow of mist is not assured. Do not remain in the area during treatment and ventilate thoroughly before re-entry.

TO OPERATE VALVE: To lock valve in open position for automatic discharge, press the valve button all the way down, hooking the catch. Then place fogger on stand or table in the center of the room with valve locked open, placing several layers of newspaper or pad under fogger. Leave building at once and keep building closed for two hours before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in two weeks or when necessary.

<u>OR</u>

TO OPERATE VALVE: To lock valve in open position for automatic discharge, press the valve button all the way down, hooking the catch. [break off and remove tab on side of sprayer. Tilt sprayer away from face (container sprays straight up). Press down firmly on sprayer pad until it snaps into place.}

To Kill Fleas and Ticks: Destroy pet's old bedding and replace. Use product as above. Treat dogs and cats with registered tick control product prior to re-entry.

STORAGE AND DISPOSAL

STORAGE: Contents under pressure. Store in a cool dry area away from heat or open flame to prevent bursting of container.

DISPOSAL: Do not puncture or incinerate!

If empty: Place in trash or offer for recycling if available.
