

- e. Change the claim, "repels mosquitoes which may carry diseases such as West Nile Virus, encephalitis and dengue." to read "Repels mosquitoes which may carry diseases such as West Nile Virus and encephalitis.". Delete dengue.

3. Submit two (2) copies of the revised final printed label for the record.


