Dear Mr. Lennan:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with the following provision(s):

#### STORAGE AND DISPOSAL section comment(s):

- 1. Replace the existing "Pesticide Storage:" subsection with "Keep this product in its tightly closed original container, when not in use. Store in a cool, dry (preferably locked) area that is inaccessible to children and animals."
- 2. Replace the existing "Pesticide Disposal and Container Handling:" subsection with:

"Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal: Nonrefillable container. Do not reuse or refill this container. If empty: Offer for recycling, if available. If partly filled: Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain."

Please submit two (2) copies of the final printed labeling, incorporating the above changes, before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with section 6(e) of FIFRA. MGK® AQUAPEL™ Pump Spray 27413 is a convenient, easy to use pump spray that allows quick and thorough application to skin, hair, and clothing for maximum protection.

Read and follow all directions and precautions on this product label. Do not apply over cuts, wounds, or irritated skin. Do not apply to eyes and mouth. Apply sparingly around ears.

Do not apply to children's hands. Do not allow children to handle this product. When using on children, apply to your own hands and then put it on the child. Use just enough repellent to cover exposed skin and/or clothing. Do not use under clothing. Avoid over-application of this product. After returning indoors, wash treated skin with soap and water. Wash treated clothing before wearing it again. Use of this product may cause skin reactions in rare cases. If you suspect that you or your child is reacting to this product, wash treated skin and call you local Poison Control Center. If you go to a doctor, take this repellent product with you.

Hold container upright about 4 - 6 inches from skin or clothing. Do not spray in enclosed areas. If used on face, spray on hands first and then apply sparingly and avoid eyes.
