Dear Ms. Schlekau:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with the following provision(s):

First Aid statement comment(s), right-hand side of page 1 of 2:

- 1. Delete the statement in the 3rd text row starting with "IF YOU SUSPECT A REACTION TO THIS PRODUCT:" Per PR Notice 2001-1, this statement should appear as revised in the Directions for Use section (as included in Point #5 below) rather than as part of the First Aid statement.
- 2. Insert the following text as a new row at the end of the existing First Aid statement as follows: "**Note to Physician:** Probable mucosal damage may contraindicate the use of gastric lavage."

Directions for Use section comment(s), right-hand side of page 1 of 2:

3. In the 10th sentence of the 2nd paragraph, replace the misspelled word "yees" with the word "eyes."

Directions for Use section comment(s), left-hand side of page 2 of 2:

- 4. Replace the last 5 sentences of the 2nd paragraph with: "When using on children, apply to your own hands and then put it on the child. Instruct older children in the proper use of this product. Apply this product second if used in conjunction with a sunscreen product. After returning indoors, wash treated skin with soap and water or bathe. This is particularly important when repellents are used repeatedly in a day or on consecutive days. Do not use under clothing. For Chiggers and Ticks, apply to shirt and pant cuffs or socks."
- 5. Replace the 4th paragraph with: "Never use repellents over cuts, wounds or irritated skin. Causes substantial but temporary eye injury. Do not get in eyes. Do not apply to children's hands. Do not use on infants. Repellents should be applied only to exposed skin and/or clothing such as shirt, pants, hat and socks. Wash hands thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove and wash treated clothing before wearing it again. Use of this product may cause skin reactions in rare cases. If you suspect a reaction to this product, discontinue use, wash treated skin and call your local poison control center. If you go to a doctor, take this repellent product with you."

The product must be packaged in containers utilizing a **concave trigger to help aim product** or other comparable mechanism that will ensure that the product will not be inadvertently sprayed in the eyes.

McLaughlin Gormley King Company should note that the Agency is in the process of developing and improving the current Efficacy Assessment Guidelines for repellent products. The Agency intends to defer the determination of any related efficacy data requirements supporting the claims that may appear on this label until these Efficacy Assessment Guidelines are complete. When the guidelines are finalized, the Agency expects to issue a Data Call-In to address the revised guidelines to all registrants with registrations for personal repellent products that have not previously submitted efficacy data sufficiently consistent with the revised guidelines.

Please submit two (2) copies of the final printed labeling, incorporating the above changes, before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes accepting of these conditions. A stamped copy of the label is attached for your records.
