The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Cypermethrin and Prallethrin Interim Decisions, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. For residual control of German cockroaches spray non-porous surfaces until coated along baseboards, under sinks, refrigerator, stove, dishwasher, or other places where cockroaches may hide. Spray for seven (7) seconds per square foot of area. [Spraying for seven seconds dispenses approximately 21 gm of product or 0.0462 lb. of product.]

Remove exposed food, dishes and utensils. All food processing surfaces should be covered during treatment or thoroughly washed before use. Do not allow children or pets to contact treated surfaces until spray has dried.


