The application referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following comments:

- 1. Remove the following claims, which are not supported or are inaccurate:
 - a) Can kill roach infestations with regular use
 - b) Effective kill of ants and roaches
 - 2. Modify the following claims as indicated:
 - a) Kills on by or through contact!
 - b) Kills ants, black carpenter ants, Argentine ants, red ants, black ants, pharaoh ants and red harvester ants
 - c) Kills fleas and brown dog ticks
 - d) Kills Southern fire ants
 - e) Keeps killing German cockroaches for up to 40 weeks (10 months) on non-porous surfaces
 - f) Long lasting control of German cockroaches for up to ten months on non-porous surfaces
 - g) For residual control of German cockroaches spray nonporous surfaces until coated along baseboards, under sinks, refrigerator, stove, dishwasher, or other places where cockroaches may hide.
- 3. The following claims are acceptable as printed on the draft label:
 - a) Kills German cockroaches on non-porous surfaces for 40 weeks (10 months)
 - b) Kills cockroaches, palmetto bugs, waterbugs, scorpions, silver fish, carpet beetles, sowbugs and Asian lady bird beetles
 - c) Kills spiders (including black widow spiders)
 - d) Contact, crack and crevice and surface spray
 - e) Kills the following [on contact]:

Ants, Argentine ants, Asian lady bird beetles, black ants, brown dog ticks, carpenter ants, carpet beetle, cockroaches [adults (nymphs)], crickets, fleas, foraging ants [fire ants], German cockroaches, palmetto bugs, pharaoh ants, red ants, red harvester ants, scorpions, silverfish, sowbugs, waterbugs [adults (nymphs)].

Spray these areas thoroughly; making certain that spray penetrates well.

<u>CONTACT APPLICATION:</u> Spray at the rate of one liner foot per second. Contact as many insects as possible with this spray, in addition to thoroughly spraying of all parts of the room suspected of harboring these pests. Pay special attention to hiding places such as beneath sinks, behind and beneath stoves and refrigerators, around garbage cans and cabinets, along the outside of baseboards, door sills, frames and floors, around and on drains, pipes and plumbing, behind bookcases, storage, and other utility installation areas, contacting insects with spray when possible.

<u>Carpet Beetles [Dermestids (Trogoderna)]</u>: Directly spray as many insects as possible. Where possible, bottom of rugs and carpets should be sprayed thoroughly. Also treat shelves, closets, areas under furniture, on floors and walls, around windowsills and baseboards, and wherever these insects are seen or suspected. Backing of carpets and rugs should be allowed to dry before re-laying on floor.

<u>Foraging Ants, Fire Ants and Foraging Carpenter Ants</u>: To kill foraging Ants, including Fire Ants and Carpenter Ants spray insects directly and ant trails.

FOR SPOT TREATMENT:

To Kill Brown Dog Ticks and Fleas: Thoroughly spray, as a spot treatment, infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings where these pests may be present. Pet's old bedding should be removed and replaced with clean, fresh bedding after treatment. DO NOT SPRAY PETS WITH THIS PRODUCT. Pets should be treated with a registered flea and tick control product prior to reentering treated areas. Also, treat your yard with a product registered for yard application.

To Kill Spiders (including Black Widow Spiders), Carpet Beetles, Cockroaches, Palmetto Bugs, Asian Lady Bird Beetles, Crickets, Scorpions, Silverfish and Sowbugs: Spray areas where these insects are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators, and cabinets; and around garbage cans, plumbing, and other utility installations. Pests driven out of hiding places should be sprayed directly.
