IMPORTANT READ ENTIRE LABEL BEFORE EACH USE

This product is a ready-to-use insecticide dust, which exhibits effective knockdown against the pests listed when used according to label directions. This product can be used in and around homes and their immediate surroundings. This product is intended for applications with a hand duster or from the shaker can, with a paintbrush or by other suitable means, to hiding and runway areas where insects are found. Keep children and pets out of treated area during application.

For most effective results, follow directions for specific use areas.

In the home cover or remove exposed food during application. Cover all food handling surfaces and utensils during application or thoroughly wash with soap and water after use.

Using a bulbous, mechanical or electric duster apply a small amount of material directly into cracks and crevices such as expansion joints between different elements of construction or between equipment bases and the floor, wall voids, motor housing, junction boxes or switch boxes, conduits or hollow equipment legs where listed insects hide. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Apply lightly and uniformly to infested area. Pay particular attention to cracks and crevices; service ducts; false floors and ceilings; wall voids; around electrical and telephone fittings and equipment; and around water and sewer pipes; under and behind cabinets; refrigerators and sinks; around windows and doorframes; along baseboards; and in attics and crawl spaces. The amount to be applied will vary with the site but usually be in the range of 0.5 lbs. per 1000 square feet.

GERMAN COCKROACH, CRICKETS, FIREBRAT, SILVERFISH, BOOKLICE, SOWBUGS, PILLBUGS, EARWIGS, CLOVER MITES AND MILLIPEDES: Distribute [MGK® F-2862] [Brand name] at the rate of 1.5 ounces per 100 square feet of surface area. Apply a continuous visible film to hiding places such as crack and crevices, behind and beneath sinks, stoves, refrigerators, around garbage cans, cabinets, along baseboards, door sills, frames and floors, around drains, pipes, plumbing, behind bookcases, storage and other utility installation. For severe infestations apply behind cabinets and walls, in crawl spaces and attics at a rate of 12 ounces per 1000 square feet.

FOR USE ON STORED PRODUCTS:

EXPOSED STAGES OF: Flour Beetles, Caddis, Rice Weevils, Flat Grain Beetles, Cigarette Beetles, Confused Flour Beetles, Drugstore Beetles, Lesser Grain Borer, Merchant Grain Beetle, Sawtoothed Grain Beetle, Grain Weevils, Warehouse Beetle, Red Flour Beetle, Grain Mites, Cheese Mites, Granary Insects and Mealworms. Find and destroy infested package goods [sacks (boxes) (cartons) (containers)]. Remove all other items from pantry, shelves and drawers. Thoroughly treat floors, walls and other surfaces in bins, storage and handling areas, shelves, drawers, cabinets, processing and handling equipment, around cartons or containers and other areas where these insects tend to congregate.

CARPENTER ANTS: Treat doors, around window frames, ant trails and hills, cracks and crevices and other areas of entry.

BEDBUGS: Apply to cracks and crevices where evidence of bedbugs occurs. This includes bed frames, box springs, inside empty dressers and clothes closets and carpet edges, high and low wall moldings and wallpaper edges. Do not use this product on mattresses, pillows, bed linens, or clothes. Remove all clothes and other articles from dressers or clothes closets before application. Not recommended for use as sole protection against bedbugs. If evidence of bedbugs is found in/on mattresses use products approved for this use.

FOR USE IN LISTED PET AREAS: Remove and destroy or wash pet's old bedding. To reduce infestation, dust around animal's bedding, sleeping quarters, kennel, around baseboards, window and doorframes, wall cracks, floors, carpeting and other resting places. Also dust the entire inside surface of doghouses. Put fresh bedding in pet's quarters.

For best results, to protect your pet against and to minimize reintroduction of adult fleas from outdoors, use EPA registered flea and tick products, ([such as; [brand name] flea or flea and tick collar, [brand name] pet powder, [brand name] pet spray, [brand name] pet dip, [brand name] pet shampoo, flea shampoo or flea and tick shampoo), in conjunction with this application and prior to re-entry.

CARPET BEETLES: Dust where these insects are found, for example on and under edges of floor coverings, around baseboards, under rugs and furniture and in closets.

OUTDOOR USE:

PERIMETER TREATMENT: Use [MGK® F-2862] [Brand name] as a treatment to kill Carpenter Ants, German Cockroaches, Crickets, Firebrats, Ground Beetles, Millipedes, Silverfish, Slugs, Sowbugs and Deer Ticks. Make a treatment around windows and doors, porches, screens, eaves, patios, garages, under stairways, in crawl spaces and other areas where pests hide. To help prevent the invasion of buildings and structures by these pests, apply thoroughly to the foundation and crawl spaces where pests are active and may find entrance.

SHRUBS and ORNAMENTALS: Apply when insects or their damage first appear and repeat at weekly intervals or as necessary. Apply 8 ounces per 1000 square feet; or thoroughly apply to place a thin layer of dust on both upper and lower sides of leaves, stems and flowers.

ROSES, PETUNIAS, CHRYSANTHEMUMS, CARNATIONS and other related flowers: To control many leaf and flower chewing insects, apply as soon as the insects appear and repeat at 7 day intervals or as long as insects continue to appear. Apply a thin layer of dust on both upper and lower sides of leaves, stems and flowers.

STORAGE AND DISPOSAL

STORAGE: Store in tightly closed container in a dry place.

DISPOSAL:

If empty: Do not reuse this container. Place in trash or offer for recycling if available.
If partly filled: Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.
