The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

#### IMPORTANT - READ ENTIRE LABEL BEFORE EACH USE

This product is a ready-to-use insecticide dust, which exhibits effective knockdown against the pests listed when used according to label directions. This product can be used in and around homes and their immediate surroundings. This product is intended for applications with a hand duster or from the shaker can, with a paintbrush or by other suitable means, to hiding and runway areas where insects are found. Keep children and pets out of treated area during application.

For most effective results, follow directions for specific use areas.

#### INDOOR USE

Do not apply directly to sewers or drains, or to any area like a gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur, except as directed by this label.

In the home cover or remove exposed food during application. Cover all food handling surfaces and utensils during application or thoroughly wash with soap and water after use.

Using a bulbous, mechanical or electric duster, apply a small amount of material directly into cracks and crevices such as expansion joints between different elements of construction or between equipment bases and the floor, wall voids, motor housing, junction boxes or switch boxes, conduits or hollow equipment legs where listed insects hide. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Apply lightly and uniformly to infested area. Pay particular attention to cracks and crevices; service ducts; false floors and ceilings; wall voids; around electrical and telephone fittings and equipment; and around water and sewer pipes; under and behind cabinets; refrigerators and sinks; around windows and doorframes; along baseboards; and in attics and crawl spaces. The amount to be applied will vary with the site but usually be in the <u>range of 0.5 lb per 1,000 square feet</u>. The maximum single application rate is 0.0009 lb a.i. per 1,000 square feet (0.9 lb of product per 1,000 square feet).

GERMAN COCKROACHES, CRICKETS, FIREBRATS, SILVERFISH, BOOKLICE, SOWBUGS, PILLBUGS, EARWIGS, CLOVER MITES AND MILLIPEDES: Distribute [MGK® F-2862] [Brand name] at the rate of 1.44 ounces per 100 square feet of surface area. Apply a continuous visible film to hiding places such as crack and crevices, behind and beneath sinks, stoves, refrigerators, around garbage cans, cabinets, along baseboards, door sills, frames and floors, around drains, pipes, plumbing, behind bookcases, storage and other utility installation. For severe infestations apply behind cabinets and walls, in crawl spaces and attics at <u>a rate of 12 ounces per 1,000 square feet.</u> The maximum single application rate is 0.0144 ounces a.i. per 1,000 square feet (14.4 ounces of product per 1,000 square feet).

#### FOR USE ON STORED PRODUCTS:

EXPOSED STAGES OF: Flour Beetles, Cadelles, Rice Weevils, Flat Grain Beetles, Cigarette Beetles, Confused Flour Beetles, Drugstore Beetles, Lesser Grain Borer, Merchant Grain Beetle, Sawtoothed Grain Beetle, Grain Weevils, Warehouse Beetle, Red Flour Beetle, Grain Mites, Cheese Mites, Granary Insects and Mealworms. Find and destroy infested package goods [sacks (boxes) (cartons) (containers)]. Remove all other items from pantry, shelves and drawers. Thoroughly treat floors, walls and other surfaces in bins, storage and handling areas, shelves, drawers, cabinets, processing and handling equipment, around cartons or containers and other areas where these insects tend to congregate. The maximum single application rate is 0.0009 lb a.i. per 1,000 square feet (0.9 lb of product per 1,000 square feet).

CARPENTER ANTS: Treat doors, around window frames, ant trails and hills, cracks and crevices and other areas of entry. The maximum single application rate is 0.0009 lb a.i. per 1,000 square feet (0.9 lb of product per 1,000 square feet).

BED BUGS: Apply to cracks and crevices where evidence of bed bugs occurs. [This includes] Apply dust to bed frames, box springs, closets, storage rooms, behind mirrors, behind picture frames, along window molding and door frames, behind headboards, under and beneath furniture, under furniture drawers and all wood joints, light switches, electrical outlets, and under edges of vents, inside empty dressers and clothes closets and carpet edges, high and low wall moldings and wallpaper edges. **Do not use this product on mattresses, pillows, bed linens, or clothes**. Remove all clothes and other articles from dressers or clothes closets before application. Not recommended for use as sole protection against bed bugs. If evidence of bed bugs is found in/on mattresses, use products approved for this use. The maximum single application rate is 0.0009 lb a.i. per 1,000 square feet (0.9 lb of product per 1,000 square feet).

CARPET BEETLES: Dust where these insects are found, for example: on and under edges of floor coverings, around baseboards, under rugs and furniture and in closets. The maximum single application rate is 0.0009 lb a.i. per 1,000 square feet (0.9 lb of product per 1,000 square feet).

#### **OUTDOOR USE:**

Do not water the treated area to the point of runoff.

Do not make applications during rain. Avoid making applications when rainfall is expected. Rainfall within 24 hours after application may cause unintended runoff of pesticide application.

Spot treatments must not exceed two square feet in size (for example, 2 ft. by 1 ft. or 4 ft. by 0.5 ft.).

For soil or foliar applications, do not apply by ground within 25 feet of lakes, reservoirs, rivers, permanent streams, marshes or natural ponds, estuaries and commercial fish farm ponds. Do not apply the product into fish pools, ponds, streams, or lakes. Do not apply directly to sewers or storm drains, or to any area like a drain or gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur. Do not allow the product to enter any drain during or after application. Do not apply directly to impervious horizontal surfaces such as sidewalks, driveways, and patios except as a spot or crack-and-crevice treatment.

PERIMETER TREATMENT: Use [MGK® F-2862] [Brand name] as a treatment to kill Carpenter Ants, German Cockroaches, Crickets, Firebrats, Ground Beetles, Millipedes, Silverfish, Slugs, Sowbugs and Deer Ticks. Make a treatment around windows and doors, porches, screens, eaves, patios, garages, under stairways, in crawl spaces and other areas where pests hide. To help prevent the invasion of buildings and structures by these pests, apply thoroughly to the foundation and crawl spaces where pests are active and may find entrance. To treat insects harbored in voids and cracks-and-crevices, applications must be made in such a manner to limit dripping and avoid runoff onto untreated structural surfaces and plants. The maximum single application rate is 0.0005 lb a.i. per 1,000 square feet (0.5 lb of product per 1000 square feet).

#### **ORNAMENTAL PLANT PESTS:**

#### Kills insects through contact:

Aphids, Beet Armyworms, Blister Beetles, Boxelder Bugs, Certain Leafminers (Boxwood, Holly, Oak, Spruce Needle), Elm Leaf Rollers, Flea Beetles, Japanese Beetles, Leaf Rollers, Leafhoppers, Orange tortrix, Periodical Cicada, Plant Bugs (Rose Chafers, Rose Midges, Rose Slugs), Tent Caterpillars. Thrips. Weevils.

SHRUBS and ORNAMENTALS: Apply when insects or their damage first appear and repeat at weekly intervals or as necessary. <u>Apply 8 ounces per 1,000 square feet</u>; or thoroughly apply to place a thin layer of dust on both upper and lower sides of leaves, stems and flowers. The maximum single application rate is 0.008 ounces a.i. per 1,000 square feet (8 ounces of product per 1000 square feet).

ROSES, PETUNIAS, CHRYSANTHEMUMS, CARNATIONS and other related flowers: To control many leaf and flower chewing insects, apply as soon as the insects appear and repeat at 7 day intervals or as long as insects continue to appear. Apply a thin layer of dust on both upper and lower sides of leaves, stems and flowers. The maximum single application rate is 0.0005 lb a.i. per 1,000 square feet (0.5 lb of product per 1000 square feet).



#### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

#### PESTICIDE STORAGE:

Store in cool, dry area. Always store pesticides in the original container. Store away from food and pet food.

#### PESTICIDE DISPOSAL AND CONTAINER HANDLING:

Non-refillable container. Do not reuse or refill this container.
