

Enclosed are 2 copies of the label. One copy has changes highlighted.

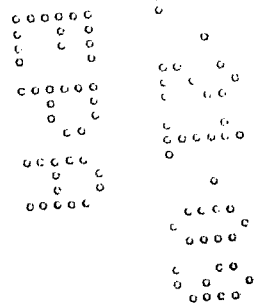

NOTE: MGK Repellent 326 may crystallize from exposure to temperatures below 70°F during shipment or storage. The drum may be filled with crystals or a layer of darker liquid over crystals. Warm drum gently to reliquify. Agitation and probing during warming will speed liquification. Do not heat above 120°F. Do not hold at elevated temperatures any longer than necessary. Agitate drum thoroughly before use. Mix well in drum before sampling and each use.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

PESTICIDE STORAGE: Store in a cool, dry place. Keep container closed.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER HANDLING:

Nonrefillable container. Do not reuse or refill this container.

Triple rinse or pressure rinse container (or equivalent) promptly after emptying. Then offer for recycling or reconditioning, or puncture and dispose of container in a sanitary landfill, or by other procedures approved by state and local authorities.

Triple Rinse as follow for containers of 5 Gallons or less: Empty the remaining contents in to application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with diluent and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use of disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

Triple rinse as follows for containers greater than 5 Gallons: Empty the remaining contents into application equipment or mix tank. Fill the container ¼ full with diluent. Replace and tighten closures. Tip container on its side and roll in back and forth, ensuring at least one complete revolution, for 20 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

Pressure rinse as follows: Empty the remaining contents in to application equipment or a mix tank. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rise at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip
