The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. One copy of the finished labeling must be submitted prior to releasing the product for shipment.

Delete from the marketing claims the following, which detract from the Precautionary Statements, Directions for Use or Storage and Disposal statements:

... fast and easy

... just pour in tank

... easy to use

...adds the convenience of total portability for today's mobile, outdoor-oriented living.

Delete picnic areas from the users manual, as this detracts from the limitation "for outdoor residential use only."

Delete the following implied safety claims:

...allowing you to enjoy your yard now

...dissipates in minutes...

Delete the following comparative claim: Finest quality

Delete the following enhanced efficacy claim: "...Certified..."

Insects are gone virtually from the moment you finish fogging...

To prevent misuse, all references to "bugs" "flying insects" and "insects" must be

revised to read "listed bugs" "listed flying insects" and "listed insects".

Add to the Storage and Disposal statements directions for disposal of the fogger.

In accordance with applicable regulations for designating distributor products and alternate brand names, you must submit to the Agency alternate brand names and/or distributor products. You must delete from the User Manual the name of companies other than the registrant. Alternately, you may revise this reference to state that the product is manufactured for Black Flag/The Fountainhead Group as appropriate.

In accordance with applicable regulations, you must submit to the Agency alternate brand names and/or distributor products. Thus you must delete from the User Manual brand names other than the primary brand name.

Delete from the User Manual the website for the Fountainhead Group. The website presents claims that detract from the product label.

In the user manual revise the advisory statement "it is not advisable to attempt fogging when the wind is blowing more than five miles an hour, since the fog will be blown away before it has the opportunity to be effective" to read "Do not apply when the wind is greater than 5 miles per hour."

Add to the Storage and Disposal statements instructions for disposing of the fogger.

In the user manual, revise the statement "Avoid breathing insecticide fog or vapors" to read "Do not breathe insecticide fog or vapors".

In the user manual, delete the statement "This is normal and should not be a cause for concern".

Revise the statement "away from children" to read "out of reach of children.

Revise the statement' "When storing the unit for extended periods of time, be sure to start with fresh insecticide upon reuse" to provide disposal instructions for any insecticide that is not fresh that may have been left in the fogger unit.

When used in [Product Name] thermal foggers, MULTICIDE® 29131 [Product Name] becomes a virtually odor-free fog that moves through the air to penetrate dense foliage to kill insects where they live and hide.

### **General Precautions and Restrictions:**

Do not allow adults, children or pets to enter until vapors, mists and aerosols have dispersed. Do not apply this product in a way that will contact adults, children or pets either directly or through drift. Do not remain in treated area. Exit area immediately and remain outside the treated area until aerosols, vapors and/or mists have dispersed. Remove or cover exposed food and drinking water before application. Do not apply directly to or near water, storm drains, or drainage ditches. Do not apply when windy. To prevent product run off, do not over water the treated areas or apply prior to heavy rainfall.
