PHYSICAL OR CHEMICAL HAZARDS

When metal cartridge comes in contact with water, and for 30 minutes thereafter, it will be hot. This is normal. In order to prevent skin burns, do NOT touch metal container during this time. Heat resistant cup protects contact surfaces.

MGK® F-2926 is a deep-penetrating fumigating fogger that flushes bugs out from where they hide and kills them on contact. When activated, it fumigates the whole room with a white cloud of smoke. The smoke stays in the air during the 3-hour treatment, penetrating deep, filling cracks and crevices and going way under furniture and appliances to kill roaches and fleas where they hide. That is why it kills so many bugs! German roaches may take longer to kill than other bugs.

One unit treats a room of 3,000 cubic feet. For best results keep treated room closed for 3 hours.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

1. Room Preparation: Open cupboards, cabinets, and drawers. Remove or cover all exposed food, dishes, and utensils. Remove plants, pets, and birds. Cover and turn off fish aquariums. Close windows and doors. Shut off fans, air conditioners, and temporarily disconnect smoke alarms.
2. Treatment: Lift pull ring and remove top from cap. Remove metal insecticide cartridge from cap.

3. Add water to line near base of plastic cup. Do not over fill. Place it on the floor in the center of the room.
4. To Actuate: Place the metal cartridge in the plastic cup. **DO NOT INSERT UPSIDE DOWN.**
5. Fumigation starts within 1-2 minutes. Leave the room and keep doors and windows closed for 3 hours.
6. After Treatment: Before re-occupying area, open all doors and windows, and air for 30 minutes. Reactivate smoke alarms.

For Use in Homes, Kennels and Non-Food areas of Commercial Buildings: Warehouses, Theatres, Office Buildings, Schools, Motels, Hotels, Restaurants and Food Processing Facilities.. Relieves infestations.
