The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Cyphenothrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance Assurance.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling and must be used at your next label printing. You must submit one copy of the final printed labeling before you release the product for

shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. After 12 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

CAUTION

Product smoke is harmful if inhaled. Avoid breathing the smoke. Avoid contact with eyes. May cause sensitization following repeated contact with the skin of susceptible individuals. Cover and turn off fish aquariums. Remove plants, pets, and birds before using. Wash hands with soap and water after handling.

Do not use in food areas of food handling establishments, restaurants, etc.

PHYSICAL OR CHEMICAL HAZARDS

When metal cartridge comes in contact with water, and for 30 minutes thereafter, it will be hot. This is normal. In order to prevent skin burns, do NOT touch metal container during this time. Heat resistant cup protects contact surfaces.

MGK® F-2926 is a deep-penetrating fumigating fogger [that kills exposed bed bugs where they hide]. When activated, it fumigates the whole room with a white cloud of smoke. The smoke stays in the air during the 3-hour treatment, penetrating deep, filling cracks and crevices and going way under furniture and appliances to kill bed bugs, roaches and fleas where they hide. German roaches may take longer to kill than other bugs.

One unit treats a room of 3,000 cubic feet. For best results keep treated room closed for 3 hours.

Kills: Bed Bugs, Roaches (Palmetto bugs and Water bugs), adult fleas, ticks, mosquitoes, flies, ants and spiders.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product

For Use in Homes, Kennels and Non-Food areas of Commercial Buildings such as: Warehouses, Theatres, Office Buildings, Schools, Motels, Hotels, Restaurants and Food Processing Facilities.

Indoor Treatment: For Indoor Use Only.

For Indoor Use Areas with multiple rooms or spaces to be treated, prepare and treat each room up to 19 ft. x 20 ft. with an 8 ft. ceiling [or 3,000 cubic feet of space separately.]

TO USE THIS PRODUCT CORRECTLY:

Do not use multiple units in a room

Do not use in small confined areas such as closets, cabinets or under counters or tables.

1. **BEFORE YOU FOG:** Open cupboards, cabinets, drawers, hampers, luggage, chests, closets, and doors in the areas to be treated. Remove or cover all exposed food, dishes, and utensils.

[Remove or cover exposed food]

Remove plants, pets, and birds. Cover and turn off fish aquarium aerators. Close windows and doors. Shut off fans, air conditioners, ventilating equipment, and temporarily disconnect or cover & seal smoke alarms with plastic. Prevent fog movement into adjoining areas or rooms by covering open duct work or vents. For best results, remove and wash bedding (sheets and blankets), empty drawers and chests, lower shades and close curtains, and remove wall plates from electrical outlets. Leave drawer contents in the room to be treated or treat in another manner. Remove cushions from sofas and chairs but leave in the room to be treated.

2. **TO START FOGGING:** DO NOT OPEN UNTIL READY TO USE. Use one treatment unit for every 3000 cubic foot area to be treated. TAKE OFF THE PLASTIC LID OF THE CONTAINER. The paper lid can be thrown away. Take the canister out of the plastic cup and remove the aluminum [foil] packaging. Fill out and place hang tag on the door to the treated area to alert family and others with access to the treated area not to enter for 3 hours.
3. Fill plastic cup with water to fill line, place unit on a flat, stable surface or on the floor in the center of the room or space to be treated. Place canister with ARROWS POINTING UP into cup with water. DO NOT OVER FILL. DO NOT INSERT CANISTER UPSIDE DOWN. The water will slowly activate the dry fogger allowing time for you to leave the room.
4. The appearance of marker smoke (not the insecticide) within 1-2 minutes is indicative of activation. **VACATE THE TREATED HOUSE, INDIVIDUAL APARTMENT UNIT, OR OTHER STRUCTURE IMMEDIATELY.** Keep doors, vents, and windows closed for 3 hours. **DO NOT RE-ENTER FOR 3 HOURS.**

5. **AIRING OUT:** Before re-occupying area, open all doors and windows, and ventilate for 30 minutes. Reactivate or uncover smoke alarms, fans, air conditioners, and ventilating equipment.

Bed Bugs: To kill [hidden] Bed Bugs [that are exposed to treatment], use one unit per 3000 cubic foot room or space to be treated. Vacuum and remove dead bed bugs after treatment. MGK F-2925(C) can be used as part of an integrated pest management (IPM) approach to control bed bugs, including use of Bedlam Aerosol Insecticide, Onslaught Microencapsulated Insecticide, and PyGanic Dust. Always read and follow all label directions for each product.

Avoid contamination of food or feedstuffs.

Do not use in food areas of food handling establishments, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed or facility is in operation. Serving areas are areas where prepared foods are served such as dining rooms, but excluding areas where foods may be prepared or held. In the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Exposed food should be covered or removed. Non-food areas are areas such as garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling).

Do not apply to classrooms when in use. Do not apply this product in occupied patient rooms or in any rooms/areas/while occupied by patients, the elderly or infirm. Do not apply in institutions (including libraries, sports facilities, etc.) in the immediate area where occupants are present.
