The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comment listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

Entomologist's Conclusion:

The Agency has reviewed the data you submitted for the claim against bedbugs and has concluded that the data for kill claims are acceptable and bedbugs may be added to your product label.

Label Revisions:

Per the May 6, 2009, label review summary for efficacy claims, and the cited product, only the following claims are allowed on the product label. All other claims must be deleted:

- Convenient-easy to use
- Delayed fogging allows time to leave room



DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Do not use in commercial food /feed handling establishments, restaurants, or other areas/sites where food/feed is commercially prepared, processed, served or stored. In the home all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use following treatment. Exposed food should be covered or removed.

- 1. Room Preparation: Open cupboards, cabinets, and drawers. Remove or cover all exposed food, dishes, and utensils. Remove plants, pets, and birds. Cover and turn off fish aquariums. Close windows and doors. Shut off fans, air conditioners, and temporarily disconnect smoke alarms.
- 2. Treatment: DO NOT OPEN UNTIL READY TO USE. TAKE OFF THE PLASTIC LID OF THE CONTAINER. The paper lid can be thrown away. Take the fumigator out of the plastic cup and tear off the aluminum packaging.
- 3. Fill plastic cup with water to fill line, Place canister with arrows pointing up into cup with water. DO NOT OVER FILL. DO NOT INSERT UPSIDE DOWN.
- 4. Place it on the floor in the center of the room. The water will slowly activate the fumigator allowing time for you to leave the room.
- 5. Fumigation starts within 1-2 minutes. Leave the room and keep doors and windows closed for 3 hours.
- 6. After Treatment: Before re-occupying area, open all doors and windows, and air for 30 minutes. Reactivate smoke alarms.
