

This product is a ready-to-use insecticide dust, which exhibits effective knockdown against the pests listed when used according to label directions. For most effective results, follow directions for specific use areas.

In the home cover or remove exposed food during application. Cover all food handling surfaces and utensils during application or thoroughly wash with soap and water after use.

Using a bulbous, mechanical or electric duster apply a small amount of material directly into cracks and crevices such as expansion ioints between different elements of construction or between equipment bases and the floor, wall voids, motor housing, juriction boxes or switch boxes, conduits or hollow equipment legs where listed insects hide. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Apply lightly and uniformly to infested area. Pay particular attention to cracks and crevices; service ducts; false floors and ceilings; wall voids; around electrical and telephone fittings and equipment; and around water and sewer pipes; under and behind cabinets; refrigerators and sinks; around windows and doorframes; along baseboards; and in attics and crawl spaces. The amount to be applied will vary with the site but usually be in the range of 0.5 lbs. per 1000 square feet.

GERMAN COCKROACH, CRICKETS, FIREBRAT, SILVERFISH, BOOKLICE, SOWBUGS, PILLBUGS, EARWIGS, CLOVER MITES AND MILLIPEDES: Distribute [MGK® F-2862] [Brand name] at the rate of 1.5 ounces per 100 square feet of surface area. Apply a continuous visible film to hiding places such as crack and crevices, behind and beneath sinks, stoves, refrigerators, around garbage cans, cabinets, along baseboards, door sills, frames and floors, around drains, pipes, plumbing, behind bookcases, storage and other utility installation. For severe infestations apply behind cabinets and walls, in crawl spaces and attics at a rate of 12 ounces per 1000 square feet.

Thoroughly treat floors, walls and other surfaces in bins, storage and handling areas, shelves, drawers, cabinets, processing and handling equipment, around cartons or containers and other areas where these insects tend to congregate.

CARPENTER ANTS: Treat doors, around window frames, ant trails and hills, cracks and crevices and other areas of entry.

CARPET BEETLES: Dust where these insects are found, for example: on and under edges of floor coverings, around baseboards, under rugs and furniture and in closets.

BEES and WASPS [Yellow Jackets, Hornets, and Paper Wasps]:

Treat bee and wasp [yellow jacket and paper wasp] nests in the evening when insects are less active and have returned to the nest. Wear protective clothing to avoid stings. Use a hand duster with extension tubes if deemed necessary. Thoroughly dust the nest entrance and surrounding areas. For best results, observe nest carefully one or two days after treatment to ensure complete kill. Remove and destroy nest. For nests in wall voids, drill a hole in the area of the nest, apply dust, and reseal.

OUTDOOR USE:

PERIMETER TREATMENT: Use [MGK® F-2862] [Brand name] as a treatment to kill Carpenter Ants, German Cockroaches, Crickets, Firebrats, Ground Beetles, Millipedes, Silverfish, Slugs, Sowbugs and Deer Ticks. Make a treatment around windows and doors, porches, screens, eaves, patios, garages, under stairways, in crawl spaces and other areas where pests hide. To help prevent the invasion of buildings and structures by these pests, apply thoroughly to the foundation and crawl spaces where pests are active and may find entrance.

SHRUBS and ORNAMENTALS: Apply when insects or their damage first appear and repeat at weekly intervals or as necessary. <u>Apply 8 ounces per 1000 square feet</u>; or thoroughly apply to place a thin layer of dust on both upper and lower sides of leaves, stems and flowers.

ROSES, PETUNIAS, CHRYSANTHEMUMS, CARNATIONS and other related flowers: To control many leaf and flower chewing insects, apply as soon as the insects appear and repeat at 7 day intervals or as long as insects continue to appear. Apply a thin layer of dust on both upper and lower sides of leaves, stems and flowers.

STORAGE AND DISPOSAL

STORAGE: Store in tightly closed container in a dry place.

On Ornamentals & Flowers (Illustration)

- Apply 18 to 16 ounces evenly over each 500 square feet of area. Repeat if there are sigs of renewed insect activity.
- Product can be applied just before planting or after plants emerge.

Vegetable Gardens (Illustration)

A single application may be applied just prior to planting or after plant emerges. Apply 16 ounces of product for a 500 square foot area and work into the top 4 to 6 inches of soil.
