- b. Under First Aid you may delete the "If Swallowed" section since the toxicity category is IV.
- c. Delete "Kills major Home Invading Ant Species [and] [Spider Species]". This is an unacceptable open-ended claim. General claims may only refer to pests 'as listed.
- d. Delete "Kills [the] 10 [Most troublesome] Home Invading Ant Species [and] [20 {Most Troublesome} Spider Species]". This also an unacceptable general claim, as 'most troublesome' species would vary considerably from region to region within the United States.
- e. Revise "Kills bugs and 99.9% of germs they may leave behind" to say Kills listed bugs and . . ."
- f. Revise "For residual control of German cockroaches spray along baseboards, under sinks,..." to read "For residual control of German cockroaches spray non-porous surfaces along baseboards, under sinks,,,".
- g. Change "dimehty" to "dimethyl" in the ingredient statement.
- h. Revise the spray distance to a maximum of 12".
- i. "New" may only be used for six months from date of this Notice of Registration.
- j. Delete "Enhanced formula!", "Double Power", "Twin Power", "Twin Strike", and "Double Strike". This implies heightened efficacy claims.
- k. Change "GermEnder" to "GermEnder™".
- 1. Delete "Fresh Pine [Spring Fresh] and "Clean [Fresh] Scent". There are no fragrances in the formulation.
- m. After "Call your local solid waste agency for disposal instructions." add "Never place unused product down any indoor or outdoor drain.".


