Subject: Label Amendment Addition of Marketing Claims MGK 29461 EPA Reg. No. 1021-2559 Submission dated August 29, 2011

Dear Mr. Ditto,

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided you:

- 1. Remove the following marketing claims: [New] [Exclusive] formula!
  - [With] GermKiller
    [With] GermBuster
    The one-two punch for household pests
    Kills bugs, fights germs
    Stops bugs and germs in their tracks
    The easy way to protect your home from bugs and germs
    Lethal to bugs and germs

The previously approved claims were specific and referred to killing the germs spread by insects or household insects only.

- 2. Remove the terms "GermKiller" and "GermBuster". No description is provided of the formulation components that these terms refer to.
- 3. Remove "[roaches]" from the claim: "Kills 99.9% of Household Germs that [roaches] [household insects [bugs] may leave behind". No references to cockroach specific studies that tested or provided data to support this claim were provided.
