The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Abamectin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. After 12 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently

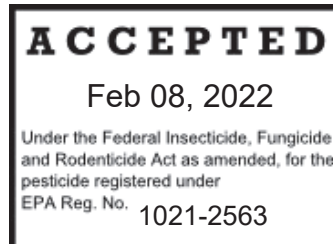

For resistance management, [MGK Roach Bait 2958] [Brand name] contains Abamectin, a Group 6 insecticide. Any insect population may contain individuals naturally resistant to [MGK Roach Bait 2958] [Brand name] and other Group 6 insecticides. The resistant individuals may dominate the insect population if this group of insecticides are used repeatedly. Appropriate resistance-management strategies should be followed.

Precautions and Restrictions

- Place bait station in areas inaccessible to children, domestic animals, and pets
- Do not contaminate feed, food products, food preparation surfaces, dishes, kitchen utensils or food containers

Application Instructions

For Best Results:

- Place bait station on a horizontal surface
- Do not interfere with the roaches or bait stations during use
- Replace [bait stations] if roaches return
- Check stations regularly and replace station if bait is consumed
- Use 4 to 6 stations per 100 square feet [2 to 3 stations per 50 square feet] of surface area to be treated. Use more stations if infestation is extreme
- Death occurs soon after feeding

How it works:

- Roaches enter the bait station and return to hiding places to die

To open, hold the bait station upright with the seal facing up and peel the seal from the top of the bait station. [Discard seal in trash].

Indoors: Place bait stations where you have noticed infestation and where roaches are numerous - along baseboards and shelves, openings leading into voids and hollow spaces in floors, walls and ceilings, equipment legs and bases, around plumbing pipes (sinks, basins, water pipes and drains), doors and window frames, behind and under appliances (refrigerators, stoves, dishwashers, washing machines, etc.), cabinets, pantries, near trash cans, basements, attics, garages, and next to cracks and crevices where cockroaches are typically seen. Outdoors: For use outdoors to control smoky brown, American, oriental, woods, and other outdoor cockroach species. Apply bait stations to points of entry or harborage sites such as to cracks and crevices on window sills, doors, porches, screens, holes where pipes or utilities enter a structure, expansion joints, beneath siding and shingles, around firewood piles, eaves, attic and soffit vents, weep holes in masonry, and similar areas. Also place stations in likely breeding areas such as behind palm fronds, crawlspaces, and similar sites. [Illustrations]

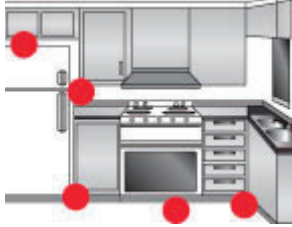
[How it works:

1. The baits inside the carton are joined. Just snap them apart and they are ready to use. Do not open or remove bait from the bait containers.
2. Place all baits around your home for the most effective result. Any area left unprotected can be the source of reinfestation for the rest of the house.
3. Cockroaches will easily walk on walls as well as floors. Use a double sided adhesive to stick baits in dark, out of the way places. No need to move pots or pans or take up valuable shelf space.
4. For best results when placing on floors, put baits adjacent to walls and flush in corners.
5. Cockroaches will begin eating the bait immediately. You should expect to see fewer cockroaches within one week.

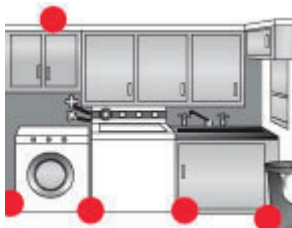
6. The replacement date is 3 months from when baits are put down. Circle the month on the base of the bait or on the reminder panel provided on the carton.]

STORAGE AND DISPOSAL
