

- 15. The proposed label includes use sites within this subsection that could possibly be interpreted as outdoor uses. Since MGK submitted a technical use deletion request for MGK-264 insecticide synergist which deleted most outdoor uses, and residential outdoor use is now limited to building surfaces/spot treatments on structures only, you must make the following changes within the "NON-FOOD LIVESTOCK [Pet] HOUSING STRUCTURES [Cages] (Premise Spray)" subsection to be consistent with MGK's outdoor use deletion request:
  - Within the subsection heading, revise the words "(Premise Spray)" to read "(Indoor Premise Spray)."
  - Insert the following new text immediately following the words "... and Sheds." within this subsection: "Do not apply this product to non-food livestock housing structures while occupied by animals."
  
- 16. Revise the text grouping immediately preceding the "STORAGE AND DISPOSAL" section to read "Apply to surfaces on buildings, around doors and windows, eaves and attic vents, utility entry points, soffit areas and other exterior openings (including foundation cracks and drilled holes) where these pests enter the structure, where they crawl or hide, or where their nests are present. Apply spray to sufficiently cover the area, but not to the point of run-off or drip from vertical or overhead surfaces. Spray for 3 seconds per 6 square feet."

Conditional Data Requirements:

- 17. Within one (1) year from the date of this registration, MGK Company must submit a One Year Storage Stability (830.6317) study and a Corrosion Characteristics (830.6320) study on this product in support of this registration. MGK Company must conduct these studies in commercial containers, and it is recommended that the observations be made at 0, 6, 9, and 12 month intervals.
  
- 3. You must submit two (2) copies of the revised final printed labeling, incorporating the above changes, before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with section 6(e) of FIFRA. Your release for shipment of the product bearing amended labeling constitutes accepting of these conditions.

Copies of your label stamped "Accepted with Comments" as well as the acute toxicology, product chemistry, and efficacy reviews completed for this product are enclosed for your records. #### USE RESTRICTIONS

Apply this product only as specified on this label.

Do not contaminate food or feedstuffs.

Do not use in aircraft cabins.

Do not apply this product directly to companion animals (pets).

Do not apply this product when food, feed, and/or drinking water is present.

Do not allow adults, children, or pets to enter the treated area until sprays have dried.

Do not apply this product in a way that will contact adults, children or pets, either directly or through drift.

Do not use in food areas of food handling establishments, restaurants, or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed or facility is in operation. Serving areas are areas where foods are served, such as dining rooms, but excluding areas where foods may be prepared or held. In the home, cover all food processing surfaces and utensils during treatment, or thoroughly wash utensils before use. Cover exposed food and drinking water, and remove utensils before use.

Do not apply directly into sewers or drains, or to any area like a gutter where drainage to storm sewers, water bodies, or aquatic habitat can occur. Do not allow the product to enter any drain during or after application.

Remove pets, birds and cover fish aquariums and ornamental fish ponds before spraying, and turn aquarium systems off.

SHAKE WELL BEFORE EACH USE.

**USE INFORMATION:** Use only as a spot treatment or crack & crevice application in residences. Spray in an inconspicuous area to test for possible staining or discoloration. Evaluate test area after drying. Remove protective cap. Hold container upright with nozzle aimed away from you. Spray surfaces from a distance of 12 inches until slightly damp. Vacate room after treatment and ventilate before reoccupying. Do not allow children or pets to contact treated areas until surfaces are dry. Allow sprayed articles and surfaces to dry thoroughly before using or replacing bedding.

For indoor use in homes, apartments, dorms, and other residential [non-commercial] living areas.

For best results before any carpet/surface treatment, vacuum thoroughly before spraying and immediately dispose of vacuum bag in outside trash.

[Thoroughly vacuum all carpeting, upholstered furniture, drapes, along baseboards, under furniture and in closets. Seal vacuum bag and dispose of in outdoor trash.]

**TO KILL CRAWLING INSECTS:** Spray as spot or crack & crevice application where insects are harboring, moving, or breeding. Treat feeding or hiding areas such as baseboards, carpet, floor, rugs, under refrigerators, cabinets, sinks, and stoves. Also treat interior entry points such as doors, around windows, and water pipes.

**FLEAS & TICKS:** Hold can upright 12 inches from surfaces to be treated. Be sure to apply uniformly using a sweeping motion to carpets, rugs, flooring, hardwood floors, drapes and all surfaces of upholstered furniture including under cushions. Avoid over wetting furniture and carpeting. A fine mist or spray applied uniformly is all that is necessary to kill fleas and ticks. Be sure to treat pet bedding, as this is a primary hiding place for fleas and ticks. No need to remove pet bedding after treatment. **DO NOT TREAT PETS WITH THIS PRODUCT.** Use a registered flea control product on your pets in conjunction with this treatment. Allow all surfaces to dry before use.

**TO KILL BROWN DOG TICKS and FLEAS:** Spray around beds, furniture and pet's habitat. Spray pet sleeping quarters, bedding, carpeting, floor and floor covering where pets are kept. Use only a recommended pet spray on pets.

**FLEAS IN BUILDINGS:** Close windows and doors. Hold aerosol 12 inches above floor and direct spray toward floor and lower walls at a rate of 2 seconds per 3-6 square feet or 15 seconds per 30 square feet, making sure that all floor, sofa, and chair surfaces are contacted. Be sure to treat pet bedding, as this is a primary hiding place for fleas and ticks. Thoroughly treat area and allow to dry. No need to remove pet bedding after treatment. Also treat dogs and cats with a registered flea control product before allowing them to enter treated area.

**FOR [FLEAS &] TICKS IN BUILDINGS:** Hold product 12 inches above floor and apply in infested areas of pet beds, resting quarters, nearby cracks and crevices, under the edges of rugs and floor coverings, behind baseboards, between and under cushions of upholstered furniture and other areas where these pests may be present. Treat higher cracks such as upper door jams and window framing, behind pictures where females may crawl to lay eggs. No need to remove pet bedding after treatment. Do not use directly on pets. Simultaneously treat pets with a flea and tick control product registered for use on pets prior to pet's entry into treated areas.

A fine spray applied uniformly is all that is necessary to kill fleas. For maximum effectiveness treat entire carpeted area. Treat carpets, rugs, drapes and all surfaces of upholstered furniture. Be sure to treat pet bedding, as this is a primary hiding place for fleas. No need to remove pet bedding after treatment. Retreat as necessary.

To kill ticks, roaches, silverfish, earwigs and ants (excluding fire, pharaoh, Carpenter and harvester ants) in the environment, apply directly to pests.

#### **FLEAS (Adults) AND TICKS (Adults): FOR USE IN HOME**

For best results, pay special attention to area your pets frequent. Avoid thoroughly wetting the area that needs treating. To kill adult flea, and adult ticks in your home, hold container [upside down] 12 feet from surface, point actuator toward the surface, and push button.

**For Surface/Carpet Spray:** Vacuum thoroughly before spraying. A test application should be made to upholstery or drapery fabrics in an inconspicuous place before use. Apply uniformly with a sweeping motion to rugs, carpets, drapes, and all surfaces of upholstered furniture. Treat surfaces uniformly from one end to the other. Only complete coverage of carpets, upholstery, drapes, and other fabrics will provide thorough flea/tick elimination.

**For Use in Pet Areas:** Pay special attention to areas where pets frequent, such as in and around sleeping and resting areas. Treat pet bedding and other pet resting areas as these are primary hiding areas for fleas/ticks. For best results, pets should be treated before they return to the treated areas.

**On Pet Bedding:** Treat pet bedding and resting places. Apply a uniform application of [this product] to nearby cracks and crevices, along and behind baseboards, window and door sills, and localized area of floors where fleas or ticks may be present as these are primary hiding places for fleas. Pet bedding does not need to be removed after treatment. [For best results, treat pets before they return to treated areas.]

**Indoor Kennels:**

**REMOVE PETS BEFORE SPRAYING**

Spray [this product] from 12 feet away from surface being treated. Apply with a smooth back-and-forth motion. A fine mist spray that is evenly applied will do the job properly. Repeat treatment as necessary to control fleas and ticks. [For best results, treat pets before they return to the treated areas.]

**BED BUGS:**

Thoroughly inspect area of suspected bed bug infestation and note potential harborage sites or actual infestations. Remove and/or pick up clothing and other obstacles that may prevent thorough inspection or treatment. Remove and sanitize infested bedding (pillows and linens), clothing, or other items. Apply on mattresses as a spot treatment to mattress seams, edges, buttons, and tufts of bed only. Do not use directly on pillows, bed linens, or clothes. Do not saturate the mattress and do not treat entire surface area of mattress. Allow mattress to dry thoroughly before replacing pillows and/or bed linens.

Bed bugs may also harbor in areas of the room away from the bed. Hold can 2 to 3 feet from surface to be treated. [Turn container upside down and point valve toward surface to be sprayed.] Apply as a crack-and-crevice or spot application where evidence of bed bugs occurs. This includes bed frames, box springs, inside empty drawers and clothes closets, night stands and other furniture in the room, carpet edges, high and low wall moldings (such as floor molding or window casings), wall voids, behind wall hangings and mirrors, wallpaper edges and popcorn ceilings. Remove all clothes and other articles from dressers or closets before application. Take bed apart. Treat joints and channels if hollow, such as square or round tubing, and see that interior framework is treated. Allow all treated areas to dry thoroughly before use.

This product is not recommended for use as a sole protection against bed bugs. If evidence of bed bugs is found in/on mattresses, use products approved for this use as part of an integrated pest management program to control bed bugs.

**CARPET BEETLES (Black, Furniture, Varied):** Apply with a sweeping motion as a surface spray to carpet, rugs, closets, baseboards, upholstered furniture, and around edges of carpet.

**TO KILL CLOTHES MOTHS AND CARPET BEETLES:** Apply as a spot treatment to cracks and crevices on and around baseboards, floorboards, furniture, and around the edges of carpet. Apply as a spot spray to carpet, rugs, closets, baseboards, furniture, on floor and floor coverings. When treating carpets or rugs, spray sufficient amount to get into the base where the larval stages are feeding. Spray both top and bottom surface of rugs or floor covering when possible.

Contact as many insects as possible. Spray into cracks and crevices where insects harbor, live and breed. Apply around cartons, containers, and furniture where these insects tend to congregate.
