Conditional Data Requirements:

- 1. Within one (1) year from the date of this registration, MGK Company must submit a One Year Storage Stability (830.6317) study and a Corrosion Characteristics (830.6320) study on this product in support of this registration. MGK Company must conduct these studies in commercial containers, and it is recommended that the observations be made at 0, 6, 9, and 12 month intervals.
- 3. You must submit two (2) copies of the revised final printed labeling, incorporating the above changes, before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with section 6(e) of FIFRA. Your release for shipment of the product bearing amended labeling constitutes accepting of these conditions.
