The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Cypermethrins Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance Assurance.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling and must be used at your next label printing. You must submit one copy of the final printed labeling before you release the product for

- Do not water the treated area to the point of runoff.
- Do not make applications during rain.
- Do not apply directly into sewers or drains, or to any area like a gutter where drainage to storm sewers, water bodies, or aquatic habitat can occur.

To protect horses, foals, and ponies from Mosquitoes and Stable Flies.

PREPARATION:

Thoroughly brush the horse's coat prior to application to remove loose dirt and debris. For dirty horses, and as a preparation for show grooming, clean the coat with a good cleansing shampoo. Wait until the coat is completely dry before applying.

Wipe-On:

For horse's face, always apply as a wipe. Apply liberally with a piece of clean, absorbent cloth, toweling (Turkish) or sponge.

Ready-to-Use Spray:

Cover entire surface of animal with spray. Avoid getting spray into horse's eyes, nose or mouth. Do not apply over cuts, wounds or irritated skin. Direct the spray to the legs, shoulders, and neck where pests appear or tend to congregate. Brush coat against the grain while spraying to insure adequate penetration of the product.

Make sure spray has dried before covering with any tack.

Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

Consult a veterinarian before using this product on debilitated, aged, medicated, pregnant, or nursing animals.

STORAGE AND DISPOSAL
