

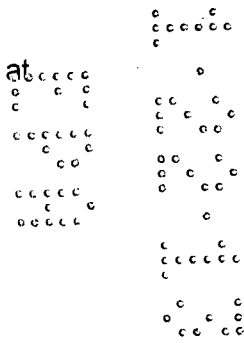
Dear Mr. Hebert:

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. Wear long-sleeved shirt and long pants, socks, shoes, and gloves. Wash hands thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet.

ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish and wildlife. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of equipment wash waters.

PHYSICAL OR CHEMICAL HAZARDS

Do not apply this product around electrical equipment due to the possibility of shock hazard.

MGK Bait Plus IGR [Brand-Name]-[VENDETTA Plus Cockroach Gel Bait] effectively kills German cockroaches and helps prevent reproduction through the effects of the insect growth regulator including inhibited development of nymphs and reproductive adults, sterility of adults, reduced insect fitness, behavioral changes, reduced egg production, deformed insects (twisted wings) and death.

For Household Use – In closets, basements, attics, recreation rooms, living areas, kitchens, bathrooms, dining rooms, pantries, food storage shelving, waste receptacles, etc.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

USE RESTRICTIONS:

- Do not apply to humans, animals, clothing, or bedding.
- Do not contaminate feed or food products, or food preparation surfaces, dishes, kitchen utensils or food containers.
- Do not use [residual] [insecticide] sprays on or near [gel] [MGK® Formula 2976] [Brand name].
- DO NOT APPLY ANY BAIT IN COCKPIT AREAS OF AIRCRAFT.

GENERAL USE DIRECTIONS:

This product is for use only as a spot or crack and crevice treatment for the indoor control of German roaches [German Cockroaches] in residential areas (only in areas inaccessible to children and pets) and both food/feed and non-food/non-feed areas of institutional, warehousing, and commercial establishments, including warehouses, restaurants, food processing plants, supermarkets, hospitals, nursing homes, motels, hotels, schools, laboratories, computer facilities, buses, boats/ships, aircraft, trains, pet shops, and zoos.

Non-food/non-feed areas area areas such as garbage rooms, lavatories, floor drains (to sewers), entries, and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling).

Food/feed areas include areas for receiving storage, packing (canning, bottling, wrapping, and boxing), preparing edible waste storage, and enclosed processing systems (mills, dairies, edible oils, and syrups). Serving areas are also considered a food/feed area when food is exposed and facility is in operation.

Do not apply bait to areas where food utensils or food preparation surfaces may become contaminated. Care should be taken to avoid depositing gel onto exposed surfaces. If gel contacts an exposed surface, remove gel and wash exposed surfaces. During follow-up visits, inspect bait placements and re-apply when necessary.

Do not place bait in locations that are routinely washed, as bait will be removed by washing. Do not place treatments in locations where routine cleansing operations may transfer diluted bait to food or food preparation surfaces. Do not use this product in or on electrical equipment where a possibility of shock hazard exists. Avoid contact with textiles and clothing, as bait may stain.

Avoid placing gel on fabrics or carpets since it may stain some absorbent materials. To prevent staining, exposed bait should be cleaned up immediately with a damp cloth or sponge.

MGK Formula 2976 [Brand-name]-[VENDETTA Plus Cockroach Gel Bait] is for use in controlling German roaches [Cockroaches] indoors. The pre-filled plastic reservoir containing **MGK Formula 2976 [Brand-name]-[VENDETTA Plus Cockroach Gel Bait]** is intended for use with bait injector application devices common to the pest control industry. Inject into cracks and crevices, void spaces, and other locations where insects may harbor, live and breed. Concentrate the bait placements as individual spots at insect activity sites (only in areas inaccessible to children and pets).

APPLICATION RATES:

For light infestations of German roaches [German Cockroaches], 4–6 bait points are recommended per 100 square feet (9.3 m2) of treatment area. For heavy infestations of German roaches [German Cockroaches], 12–24 bait points are recommended per 100 square feet (9.3 m2) of treatment areas. Each bait point should equal about 0.25 to 0.50 grams of product. A spot approximately 3 mm or 1/8 inch in diameter equals 0.25 grams of product, while a spot approximately 6 mm or 1/4 inch in diameter equals 0.50 grams of product.

TO APPLY GEL:

1. Remove the cap from the nozzle, touch the top to the surface to be treated, and push down on the plunger. Apply bait as spots in cracks and crevices. Recap the dispenser after treatment is completed.
2. Store in a cool, dry place.
3. Do not apply gel to areas that have been recently sprayed with insecticide, and do not spray insecticide over gel, as this may cause the bait to become repellent.
4. The bait will adhere to non-greasy or non-dusty surfaces and will remain pliable and palatable to German roaches [German Cockroaches] as long as it is visibly present.
5. A visual inspection of bait placements is recommended at one month after the initial treatment. Reapply when bait is no longer visibly present, according to the level of infestation. [Replace bait before it is] [Do not allow bait to be] completely consumed to keep German roaches [German Cockroaches] from returning.

APPLICATIONS IN AIRCRAFT: DO NOT APPLY ANY BAIT IN COCKPIT AREAS OF AIRCRAFT Application within passenger areas of aircraft is limited to Crack & Crevice treatment only. Apply [MGK Formula 2976 ~~[Brand name]~~ **VENDETTA Plus Cockroach Gel Bait**] in areas between elements of construction (such as areas under sinks, openings around pipes, under shelving, where shelving meets other shelves or the wall, areas between and around microwaves, where support braces attach to the main structure and where seats are attached to the floor). Use 12 -24 bait placements per 100 sq. ft (9.3 m2).

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE:

Store in a cool, dry place. Always store pesticides in the original container. Store away from food and pet food.

PESTICIDE DISPOSAL AND CONTAINER HANDLING:

Nonrefillable container. Do not reuse or refill this container.

If empty:

Place in trash or offer for recycling if available.

If partly filled:
