The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Momfluorothrin and Cypermethrin Interim Decisions, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. Do not apply to surfaces where prolonged human contact will occur. Also for spot treatment of luggage, closets, drapes and other window or wall appointments.

[Take bed apart. Treat joints and channels if hollow, such as square or round tubing, and treat the interior framework. Treat tufts, folds, and edges of mattresses. Cover mattresses before use. [Bedbugs: Spray tufts, folds and seams of mattresses. Take beds apart and spray into all joints. Treat baseboards, moldings, and floors. After mattress is dry, cover with mattress cover and sheet. Do not use mattress without a cover. Retreat if infestation occurs. Insects must be contacted directly.]

Apply as a crack and crevice or spot application where bed bugs are present. This includes bed frames, box springs, inside empty drawers and clothes closets, night stands and other furniture in the room, carpet edges, high and low wall moldings (such as floor molding or window casings), wall voids, behind wall hangings and mirrors, wall paper edges and popcorn ceilings. Remove all clothes and other articles from dressers or closets before application. Take bed apart. Treat joints and channels if hollow, such as square or round tubing and see that interior framework is treated. Allow all treated areas to dry thoroughly before use. Insects must be contacted directly.

This product is not recommended for use as a sole protection against bed bugs. If evidence of bed bugs is found in/on mattresses, use this product as part of an integrated pest management program to control bed bugs.

FOR SPOT TREATMENT:

To Kill Brown Dog Ticks and Fleas: Thoroughly spray, as a spot treatment, infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings where these pests are present.
