The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Phenothrin and Momfluorothrin Interim Decisions, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance Assurance.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling and must be used at your next label printing. You must

This pesticide is highly toxic to fish and aquatic invertebrates. Drift and runoff may be hazardous to aquatic organisms in water adjacent to treated areas. - Do not apply by ground within 25 feet of lakes, reservoirs, rivers, permanent streams, marshes or natural ponds, estuaries and commercial fish farm ponds.

 or storm drains, or to any area like a drain or gutter where drainage to sewers, storm drains, water

Before spraying insects, shake can and give a short burst to ensure proper pressure. Kills insects where they live and breed. Insects will fall to the ground and die after spraying.

Option 1: Spot Spray

- 1. Spray 1 to 2 seconds until surface is moist to kill listed pests under eaves, around screens, windows, doors, patios, cracks, holes and crevices or wherever listed pests are noticed.
- 2. To prevent listed pests from entering the home, spray around areas where they enter such as outdoor plumbing, faucets, etc. and cracks or crevices in foundations as well as along sills and ledges.

Spider & Scorpion Spot Spray Option

To kill Spiders (excluding Black Widow, Brown Recluse and Hobo Spiders) and Scorpions:

- 1. Spray underside of eaves 1 to 2 seconds until surface is moist to kill spiders. Also apply as a spot treatment to building surfaces, around screens, windows, doors, patios, cracks, holes and crevices or wherever listed pests are noticed.
- To prevent listed pests from entering the home, spray around areas where they enter such as outdoor plumbing, faucets, etc. and cracks or crevices in foundations as well as along sills and ledges.

Spider & Scorpion Direct Spray Option

To kill (other insects, including) Spiders (excluding Black Widow, Brown Recluse and Hobo Spiders), and Scorpions as direct spray:

- 1. Spray short 1 to 2 second bursts directly on listed pests.
- 2. For scorpions, stand 3 to 4 feet away and thoroughly cover the insect. Make sure scorpions are dead before removing.

Use Tips:

- 1. If windy, stand with the wind at your back to avoid spray drift.
- 2. Avoid spraying vegetation directly.
- 3. Rinse with water any desirable foliage that is contacted with spray.
- 4. Avoid spraying desirable plants. Rinse with water any desirable foliage that is contacted with spray.
- 5. This product may stain vinyl, painted, and plastic surfaces. Avoid application to asphalt roofing shingles as staining may occur. Before using in areas where spray may contact these surfaces, test in an inconspicuous area and recheck in a few hours.
