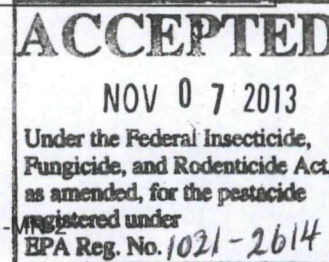

#### **Application Instructions:**

##### **For Best Results:**

Application rate is dependent on level of infestation and species to be controlled. Several smaller placements will provide faster control than a few larger spots, especially for German cockroach control.

The lower application rate should be used for low to moderate infestations. Use the higher rate for more severe infestations. Placements should be at or near harborage or congregation areas such as cracks and crevices, corners or other areas of movement.

- Do not apply gel to areas which have been recently sprayed with insecticide
- Check placements regularly and reapply if bait is consumed

#### **HOW IT WORKS:**

- Roaches eat the bait and return to hiding places to die

#### **HOW TO USE:**

To apply gel, remove the cap on the nozzle, touch the application tip to the surface and apply. The bait will adhere to non-greasy or non-dusty surfaces.

#### **HOW MUCH TO USE [APPLY]:**

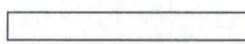


Figure 3: Line of gel approximately 1/8 inch x 2 inches
