The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Deltamethrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. 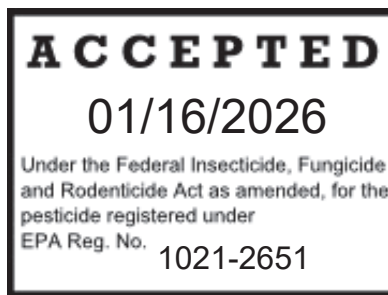

- Do not allow adults, children, or pets to enter the treated area until sprays have dried.
- Do not apply this product in a way that will contact adults, children or pets, either directly or through drift.
- Remove pets, birds and cover fish aquariums before spraying.
- Do not apply as a space spray. Apply to surfaces only.
- Do not wet articles to the point of runoff or drip. Do not use treated article until spray has dried.

- Do not make outdoor applications at residential sites during rain.

- All outdoor spray applications must be limited to spot or crack-and-crevice treatments only, except for the following permitted uses:

1. Application to pervious surfaces such as soil, lawn, turf, and other vegetation;
2. Perimeter band treatments of 7 feet wide or less from the base of a man-made structure to pervious surfaces (e.g., soil, mulch, or lawn);
3. Applications to underside of eaves, soffits, doors, or windows permanently protected from rainfall by a covering, overhang, awning, or other structure;
4. Applications around potential exterior pest entry points into man-made structures such as doorways and windows, when limited to a band not to exceed one inch;
5. Applications to vertical surfaces (such as the side of a man-made structure) directly above impervious surfaces (e.g., driveways, sidewalks, etc.), up to 2 feet above ground level;
6. Applications to vertical surfaces directly above pervious surfaces, such as soil, lawn, turf, mulch or other vegetation) only if the pervious surface does not drain into ditches, storm drains, gutters, or surface waters.

- Spot treatments must not exceed two square feet in size. (for example 2 ft by 1. Ft. or 4 ft. by 0.5 ft).
- Do not apply by ground within 25 feet of lakes, reservoirs, rivers, permanent streams, marshes or natural ponds, estuaries and commercial fish farm ponds.

- Do not apply the product into fish pools, ponds, streams, or lakes. Do not apply directly to sewers or storm drains, or to any area like a drain or gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur.

- Treat surfaces to ensure thorough coverage but avoid runoff. To treat insects harbored in voids and cracks-and-crevices,

applications must be made in such a manner to limit dripping and avoid runoff onto untreated structural surfaces and plants.

UltraTec D 200 Insecticide has residual action which keeps on killing **German & American Cockroaches and Argentine Ants** for up to 12 Months (1 Year) on non-porous surfaces and **House Flies** for up to 12 weeks (3 months) after you spray.

Remove pets, birds and cover fish aquariums before spraying. Prevent re-entry of dogs and cats into treated area until spray deposits are dry.

Test product on an inconspicuous area before applying. Spray until surface is slightly wet, but not to the point of runoff. Over application may cause damage. Will not stain surfaces or fabrics where water alone causes no damage.

SHAKE WELL BEFORE EACH USE. Hold container upright. Do not spray up into air. Apply to surfaces only. [Remove protective cap and direct spray away from face.] [Twist and snap off tab before spraying. Direct spray away from face.] Hold can 12-15 inches from surface being sprayed. Press button down and spray as directed.

UltraTec D 200 Insecticide is intended for use in and around residential structures and their immediate surroundings. Permitted areas of use include: apartments, atriums, attics, automobiles, basements, bathrooms, boats, cabins, campers, carports, cat sleeping quarters, clothes storage, condominiums, decks, dens, driveways, garages, gazebos, homes, kitchens, lanais, living rooms, parlors, patios, pet sleeping areas, play rooms, porches, recreational vehicles, rooms, solariums, storage areas, sun rooms, utility rooms and verandas.

Application is prohibited directly into sewers drains, or to any area like a gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur. Do not allow the product to enter any drain during or after application.

#### INDOORS:

**Cockroaches (including Adult and Immature Stages of Both Non-Resistant and Organophosphate and Carbamate Resistant Strains), Ants, Booklice, Boxelder Bugs, Centipedes, Crickets, Dermestids, Firebrats, Fleas, Palmetto Bugs, Silverfish, Sowbugs, Ticks and Waterbugs:** Apply as a spot and crack and crevice treatment to areas where these pests crawl and hide, especially in hidden areas around sinks and storage areas, behind baseboards, around doors and windows, behind and under refrigerators, cabinets, sinks and stoves, the underside of shelves, drawers, bookcases, and similar areas. When pests are driven out, spray directly. Cover all food handling surfaces and cover or remove all food and cooking utensils or wash thoroughly after treatment. Exposed food should be covered or removed. Repeat as necessary but not more than once per week.

[**Roaches:** Spray in cracks and crevices, around baseboards and other hiding places until wet. When driven out, spray bugs directly.]

**Ants:** Spray ant trails and around doors and windows and other places where ants enter the house. Repeat as necessary but not more than once per week.

**Carpenter Ants:** For effective control, locate and treat nests and surrounding areas. Apply around doors and windows and other places where ants enter premises and where they crawl and hide. Spray into infested wood through existing openings.

**Ticks and Fleas ON SURFACES:** Remove pet bedding and destroy or clean thoroughly. Spray pet resting quarters. Adult fleas and larvae contacted by spray will be killed. Put fresh bedding down once spray has dried. Do not spray animals directly. For best results, pets should be treated with an appropriate flea and/or tick control product registered for use on pets before allowing them to return to the treated area. Spray rugs and carpets where infestations are bad. Test first for staining on an inconspicuous piece prior to use.

**Spiders:** Apply along and behind baseboards, to window and door frames, corners, pipes, storage localities, attics, crawl spaces and other areas over which these pests may crawl.

**Centipedes, Ground Beetles, Pillbugs, Sowbugs, Scorpions and Ticks:** Apply around doors and windows and other places where these pests may enter premises. Treat baseboards, storage areas and other locations where these pests are found.

[**Silverfish, Crickets, Spiders:** Apply to areas infested by these pests (around doors and windows, along baseboards, in storage areas and other locations where pests are found) or spray pests directly. Spray surfaces until wet.]

**CONTACT SPRAY:** To kill **ants (including carpenter, fire, harvester & pharaoh ants), bed bugs, centipedes, cockroaches, fleas, spiders (including brown recluse, black widow & hobo spiders), ticks, chiggers, black flies, deer flies, horse flies, gnats, biting midges and wasps:** Spray where insects congregate and individual pests when seen. Spray 1-3 seconds contacting insects directly. Insects contacted by spray will be killed.

#### PANTRY PESTS -

**Grain Beetles (Rusty, Merchant and Sawtoothed), Flour Beetles (Red and Confused), Chocolate Moths, Cigarette Beetles, Clover Mites, Cluster Flies, Drugstore Beetles, Elmleaf Beetles, Rice Weevils, Lesser Grain Borers, Spider Beetles and Tobacco Moths:** Treat exposed stages. Remove all food-stuffs, utensils and shelf paper from area to be treated. Discard used shelf paper and any infested foodstuffs. Apply spray to shelves and in cracks and crevices behind and under cupboards and cabinets. Allow spray to dry prior to replacement of shelf paper, food and utensils. Wash any exposed food handling surfaces and utensils before use.

**Carpet Beetles (Black, Furniture and Varied):** Spray on and under edges of floor coverings, under rugs and furniture and in closets or other localities where these insects are found.

**Webbing Clothes Moths:** Use this product as a crack and crevice treatment in closets and other storage areas where these pests are found. This is an adjunct treatment and will not control moth larvae already on clothes. Do not apply to clothing.

## OUTDOORS:

Remove all exposed food and cooking utensils. Cover all food handling surfaces and/or wash thoroughly after treatment and before use. Do not use on edible crops.

Point nozzle away from face. Hold can on a slight downward angle, approximately 12 - 15 inches from surface to be sprayed. For best results, spray when air is calm. Spray with wind if breeze is blowing.

**PESTS ON OUTSIDE SURFACES OF BUILDINGS:** For control of building infestation by **Ants, Clover Mites, Crickets and Sowbugs (Pillbugs)**. Spray foundation of building where insects are active and may find entrance up to a height of 2 feet. Apply as a residual spray to outside surfaces of buildings where insects tend to congregate. Spray areas include (but are not limited to) screens, window frames, eaves, porches, patios, garages and refuse dumps. Repeat treatment as necessary but not more than once per week.

**CRAWLING INSECTS:** **Ants, Cockroaches (including Asian Cockroaches), Centipedes, Crickets, Mole Crickets and Silverfish.** Hold can 12 to 18 inches from surface to be treated and spray in infested surface of patio or picnic area, hitting as many insects as possible. Spray to slightly moisten the surface. Also spray legs of tables and chairs to repel ants. Spray ant hills for best control.

**Ants:** Spray around ant trails and hills. Spray around nests hidden under steps, brickwork, concrete, etc. Break apart accessible nests and spray on and around debris until surface is slightly wet. Repeat as necessary but not more than once per week.

[**Ants:** Spray ant trails and hills. If nest can be located, spray surface of nest until wet.]

**Lone Star Ticks, Dog Ticks, Crickets, Fleas and Earwigs:** Apply thoroughly to infestations in bushes, grass or weeds.

**Asian Lady Bird Beetles (Lady bugs):** Spray areas where bugs crawl or rest, especially around doors, on and around screens, windows, doorframes and areas where insects can enter the home. Remove screens prior to spraying them, allow to dry and then reinstall them.

**Wasps, Hornets and Bees:** Spray nests and bees directly. Aim spray at nest openings. Applications should be made late in the evening when insects are at rest.

**FLYING INSECTS: House Flies, Gnats, Mosquitoes and Small Flying Moths:** Use only on outdoor surfaces. Spray outside surfaces of window and door frames and other areas where these pests may enter the home. Also spray localized resting areas, such as under eaves, porches, surfaces around light fixtures and cords, railings, etc. where these insects may rest. Insects coming to rest on treated surfaces will be killed.

### FOR THE CONTROL OF GARDEN INSECTS:

For use on roses, dahlias, asters and other ornamentals to kill **Japanese Beetles** hit by spray, as well as **Whiteflies, Aphids, Exposed Thrips, Spiders, Red Mites and Leafminers.**

May be used on plants, as well as a multi-purpose spray in small ornamental gardens and for spot treatments of incipient insect infestations to prevent spreading in large garden areas.

Effective when used as directed against **Whiteflies, Aphids, Spider and Red Mites, Exposed Thrips, Lace Bugs, Japanese Beetles, Pavement Ants, Clover Mites and Armyworms.** When spraying plants, do not operate closer than 18 inches. Use sweeping motion. Spray in one second bursts. Be cautious about wetting tender foliage, young plants and new growth. Do not spray plants when temperatures exceed 90°F. Over application may cause damage. Spray insects directly whenever possible. Repeat treatment as necessary but not more than once per week.
