The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Permethrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. INDOORS

Cluster Flies, House Flies, Fruit Flies, Mosquitoes, Gnats, Wasps, Hornets, Bees, Black Flies, Skipper Flies, Blow Flies and Small Flying Moths: Close all doors and windows and direct spray upward into center of room with a slow sweeping motion. Spray 5-10 seconds for average room, moving toward the door. Direct spray to all parts of the room, especially windows and other light sources which attract these insects. Keep nozzle in constant motion. Leave room and keep area closed for 15 minutes after spraying. Sweep up and discard fallen insects.

Cockroaches, Waterbugs, Palmetto Bugs, Silverfish, Firebrats, Crickets, Scorpions, Spiders, Millipedes, Centipedes, Sowbugs and Pillbugs: Spray into hiding places such as cracks and crevices, behind sinks, cabinets, along baseboards and floors, around drains and plumbing, hitting insects with spray whenever possible.

Ants: Spray trails, nests and points of entry. Spray on ants where possible.

Indian Meal Moths, Angoumois Grain Moths: Close doors and windows, direct spray into all parts of room especially around stored food product containers, pallets and darkened areas. Spray 7 to 10 seconds for each 1,000 cu. ft. of space, moving toward the door. Leave room and keep area closed for 15 minutes following treatment.

EXPOSED STAGES OF *Confused Flour Beetles, Cigarette Beetles, Drug Store Beetles, Sawtoothed Grain Beetles, Red Flour Beetles, Rice Weevils, Granary Weevils, Grain Mites in Exposed Adult and Larvae Stages*: Spray into cracks and crevices, processing and handling equipment, around cartons or containers or other areas where these insects tend to congregate. Contact as many insects as possible. Spray 30 seconds for each 100 sq. ft. of surface. Keep area closed for 45 minutes to 1 hour after treatment. Space spray: Spray 20 seconds per 1,000 cu. ft. of space, moving toward the door. Leave room and keep area closed for 15 minutes following treatment. Dispose of infested stored food products or treat using an approved product intended for this purpose.

Carpet Beetles: Spray directly on beetles, floors, baseboards, shelves and carpets.

Bed Bugs: Spray mattresses, particularly around tufts and seams. Take beds apart and spray into all joints. Treat baseboards, moldings and floors.

TO CONTROL *Clothes Moths and Carpet Beetles* on wool and other proteinaceous fibers: Remove infested articles from storage, brush thoroughly, and air for several hours in sunlight, if possible. Apply spray liberally to empty chests, closets, bureaus and other storages directing the spray into cracks, joints and crevices. After airing, infested articles may be treated by spraying lightly, keeping nozzle at least three feet from fabric to avoid staining.

Fleas IN BUILDINGS - SPACE SPRAY: Hold can 36 inches above floor and direct spray toward floor and lower walls at a rate of 10 seconds per 100 sq. ft. making sure that all floor, sofa and chair surfaces are contacted. Leave room and keep area closed for 15 minutes.

Fleas & Ticks (Adults and Larvae): Remove and thoroughly clean or destroy pet bedding. Spray pet sleeping quarters, bed, entire floor and floor covering, with special attention to cracks and crevices around baseboards, and window and door frames. Infested upholstered furniture and mattresses may also be treated with this product.

TO KILL *Lice and Louse Eggs*: Spray entire area to be treated. Hold container upright with nozzle away from you. Depress valve and spray from a distance of 8 to 10 inches. Spray each square foot for three seconds. Spray only those garments and parts of bedding, including mattresses and furniture that cannot be either laundered or dry-cleaned.

IN ANIMAL QUARTERS: For rapid control of *House Flies, Mosquitoes, Gnats, Wasps, Hornets, Bees and Small Flying Moths*, close windows and doors and spray at the rate of 2 seconds per 1,000 cu. ft. of space. For best results, keep area closed for 10 minutes after spraying.

TO TREAT LIVESTOCK: To protect beef cattle, dairy cattle, goats, sheep, hogs and horses from attacks of **Stable Flies, Horse Flies, Deer Flies, Face Flies, Horn Flies, Mosquitoes, and Gnats**: Spray about 3 seconds on each side being careful to spray back, withers and forelegs thoroughly. • Do not apply by ground within 25 feet of lakes, reservoirs, rivers, permanent streams, marshes or natural ponds, estuaries and

- commercial fish farm ponds.
- Do not spray the product into fish pools, ponds, streams, or lakes.
- Do not apply directly to sewers or storm drains, or to any area like a drain or gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur.

- Do not apply directly to impervious horizontal surfaces such as sidewalks, driveways, and patios except as a spot or crack-and-crevice treatment
 - [Alternate text: When used in dairy barns or facilities: Close milk bulk tank lids to prevent contamination from dead or falling insects. Remove or cover milking utensils before application. Wash teats of animals before milking.]
 - Do not use in outdoor residential misting systems.
 - Remove or cover exposed food and drinking water before application.
 - Remove or cover dishes, utensils, food processing surfaces and equipment, wash them before use.
 - Do not use in food areas of food handling establishments, restaurants, or other areas where food is commercially prepared or

 - Commercial food/feed areas where the product cannot be used include areas for receiving, serving, storage (Dry, Cold, Frozen, Raw), packaging (Cleaning, Slicing, Cooking, Grinding), edible, waste storage, enclosed processing systems (Mills, Dairies, Edible Oils, Syrups).

SHAKE WELL BEFORE USING

Remove protective cap, hold container upright and spray from a distance of 12 to 15 inches.

When treating surfaces and fabrics where water alone could stain, spray in an inconspicuous area to test for possible staining or discoloration.

For Crack and Crevice Treatments:

Treat surfaces to ensure thorough coverage but avoid runoff. To treat insects harbored in voids and cracks-and-crevices, applications must be made in such a manner to limit dripping and avoid runoff onto untreated structural surfaces and plants.

INDOORS:

Cluster Flies, House Flies, Fruit Flies, Mosquitoes, Gnats, Wasps, Hornets, Bees, Black Flies, Skipper Flies, Blow Flies and Small Flying Moths: Close all doors and windows and direct spray upward into center of room with a slow sweeping motion. Spray 5-10 seconds for average room, moving toward the door. Direct spray to all parts of the room, especially windows and other light sources which attract these insects. Keep nozzle in constant motion. Leave room and keep area closed for 15 minutes after spraying. Sweep up and discard fallen insects.

Cockroaches, Waterbugs, Palmetto Bugs, Silverfish, Firebrats, Crickets, Scorpions, Spiders, Millipedes, Centipedes, Sowbugs and Pillbugs: Spray into hiding places such as cracks and crevices, behind sinks, cabinets, along baseboards and floors, around drains and plumbing, hitting insects with spray whenever possible.

Ants: Spray trails, nests and points of entry. Spray on ants where possible.

Indian Meal Moths, Angoumois Grain Moths: Close doors and windows, direct spray into all parts of room especially around stored food product containers, pallets and darkened areas. Spray 7 to 10 seconds for each 1,000 cu. ft. of space, moving toward the door. Leave room and keep area closed for 15 minutes following treatment.

EXPOSED STAGES OF Confused Flour Beetles, Cigarette Beetles, Drug Store Beetles, Sawtoothed Grain Beetles, Red Flour Beetles, Rice Weevils, Granary Weevils, Grain Mites in Exposed Adult and Larvae Stages: Spray into cracks and crevices, processing and handling equipment, around cartons or containers or other areas where these insects tend to congregate. Contact as many insects as possible. Spray 30 seconds for each 100 sq. ft. of surface. Keep area closed for 45 minutes to 1 hour after treatment. Space spray: Spray 20 seconds per 1,000 cu. ft. of space, moving toward the door. Leave room and keep area closed for 15 minutes following treatment. Dispose of infested stored food products or treat using an approved product intended for this purpose.

Carpet Beetles: Spray directly on beetles, floors, baseboards, shelves and carpets.

Bed Bugs: Spray mattresses, particularly around tufts and seams. Take beds apart and spray into all joints. Treat baseboards, moldings and floors.

TO CONTROL *Clothes Moths and Carpet Beetles* on wool and other proteinaceous fibers: Remove infested articles from storage, brush thoroughly, and air for several hours in sunlight, if possible. Apply spray liberally to empty chests, closets, bureaus and other storages directing the spray into cracks, joints and crevices. After airing, infested articles may be treated by spraying lightly, keeping nozzle at least three feet from fabric to avoid staining.

Fleas IN BUILDINGS - SPACE SPRAY: Hold can 36 inches above floor and direct spray toward floor and lower walls at a rate of 10 seconds per 100 sq. ft. making sure that all floor, sofa and chair surfaces are contacted. Leave room and keep area closed for 15 minutes.

Fleas & Ticks (Adults and Larvae): Remove and thoroughly clean or destroy pet bedding. Spray pet sleeping quarters, bed, entire floor and floor covering, with special attention to cracks and crevices around baseboards, and window and door frames. Infested upholstered furniture and mattresses may also be treated with this product.

TO KILL *Lice and Louse Eggs*: Spray entire area to be treated. Hold container upright with nozzle away from you. Depress valve and spray from a distance of 8 to 10 inches. Spray each square foot for three seconds. Spray only those garments and parts of bedding, including mattresses and furniture that cannot be either laundered or dry-cleaned.

IN ANIMAL QUARTERS AND MILK ROOMS: For rapid control of *House Flies, Mosquitoes, Gnats, Wasps, Hornets, Bees and Small Flying Moths*, close windows and doors and spray at the rate of 2 seconds per 1,000 cu. ft. of space. For best results, keep area closed for 10 minutes after spraying.

TO TREAT LIVESTOCK: To protect beef cattle, dairy cattle, goats, sheep, hogs and horses from attacks of **Stable Flies, Horse Flies, Deer Flies, Face Flies, Horn Flies, Mosquitoes, and Gnats**: Spray about 3 seconds on each side being careful to spray back, withers and forelegs thoroughly. To protect from **Face Flies**, spray the face and head, but do not spray into eyes.

FOR SWINE: Do not ship animals for slaughter within 5 days of last treatment.

TO CONTROL Blood-Sucking Lice: Apply to the infested areas of the animal, using a stiff brush to get the spray to the base of the hair.

TO CONTROL **Poultry Lice**: Spray roosts, walls and nests or cages thoroughly. This should be followed by spraying over the birds with a fine mist.

FOR CONTROL OF **Bed Bugs and Mites** in poultry houses, spray crevices of roost poles, cracks in walls, and cracks in nests where the bed bugs and mites hide.

OUTDOORS:

Point spray nozzle away from face. Hold can on slight downward angle. For best results, spray when air is calm. Allow a few minutes for product to take effect. Spray with wind if breeze is blowing. Take precautions to minimize spray drift.

FLYING INSECTS: *Flies, Mosquitoes, Gnats, Small Flying Moths, Hornets and Yellowjackets*. Allow fog to drift over area. Direct spray toward bushes or grass from at least 4 to 6 feet away. Give special attention to breeding areas such as garbage cans and compost piles.

Mud Daubers and Wasp Nests: Spray mist directly on insects and their nests from approximately 2 feet away. Contacted insects will fly away from fog. Apply in late evening when insects are at rest. Spray into hiding and breeding places contacting as many insects as possible. Take precautions to minimize spray drift.

CRAWLING INSECTS: Ants, Cockroaches, including Asian Cockroaches, Crickets, Mole Crickets, Centipedes and Silverfish. Spray infested surface of patio or picnic area, hitting as many insects as possible. Also spray legs of tables and chairs to repel ants. Spray ant hills for best control.
