If application is made indoors, remove infested plants from living area prior to application. Dust plants in an area not likely to be occupied by children or fets (particularly fish). When dust settles plants can be returned to original location.

Use with care on ferns, palms and fuchsia. As with all plants listed above, especially carnations, chrysanthemums and roses, there exists a wide variety of species and cultivars, and therefore, a wide variety of susceptibility to injury. To ascertain possible phytotoxicity, dust a few plants a described above, wait 24 hours and check for possible injury.

Repeat applications may be necessary to control adult Japanese Beetles on roses.
