Dear Mr. Ditto:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance

Only for Formulation into an insecticide for the following uses: Domestic Indoor (household); Domestic Outdoor (household, ornamentals); Terrestrial Non-Food.

All liquid and RTU products labeled for use on indoor surfaces (baseboard, spot, and crack and crevice) at residential sites must be formulated to contain no more than 0.5% of permethrin active ingredient.

All liquid products labeled for use on indoor surfaces must state the following "Not for broadcast use."

Outdoor Residential Misting Systems are not to exceed 0.25 grams permethrin per 1000 cubic feet per day.

Total release foggers labeled for indoor use at residential sites must be formulated to contain no more than 0.58% permethrin active ingredient.

For use in factory applied coatings (such as water repellent, fire retardant and stain resistant matrices) used in/on fabrics (for tents, shelters, truck covers, awnings, hunting blinds and nettings); outerwear garments (for coats, jackets, coveralls, gaiters, chaps, hat bands, bibs and vests); and domestic animal [dogs, cats, horses] care products (such as pet bedding, blankets, rugs, netting and kennel/stall coverings) as an insecticide and/or repellent against *Ticks, Mosquitoes, Spiders, Ants, Fleas, Flies and other Flying and Crawling insects*. Also for use in/on fabrics for carpeting as an insecticide and repellent against *Dust Mites*. For optimum performance of treated materials, incorporate into the coatings matrix of fabrics not to exceed an application rate equivalent to 1.25 grams Permethrin per square meter of fabric. Insects which come into contact with treated fabric surfaces will be killed; insects which come near treated fabric surfaces will be repelled.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

<u>PESTICIDE STORAGE AND SPILL PROCEDURES</u>: Store upright at room temperature. Avoid exposure to extreme temperatures. In case of spill or leakage, soak up with an absorbent material such as sand, sawdust, earth, fuller's earth, etc. Dispose of with chemical waste.

Triple rinse container (or equivalent) promptly after emptying.

Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with solvent used in the end use product and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

(Greater than 5 gallons/50 lbs.)

Triple rinse container or equivalent promptly after emptying.

Triple rinse as follows: Empty the remaining contents into application equipment or mix tank. Fill the container ¼ full with solvent used in the end use product. Replace and tighten closures. Tip the container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip back forth several times. Empty the rinsate in to application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.
