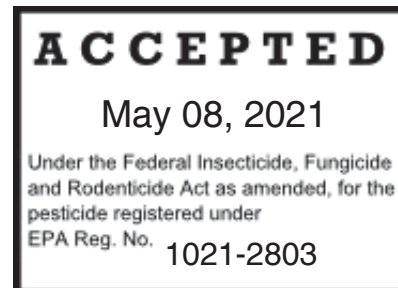

- **Outdoor** areas around barns, garages, horse stables, houses and other residential structures, sheds and other outbuildings. Scatter bait in areas inaccessible to children, pets and animals.
- **Indoor** application in barns, garages, horse stables, sheds and other out buildings. Scatter bait in areas inaccessible to children, pets and animals.

**Bait Station Application**
