The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.



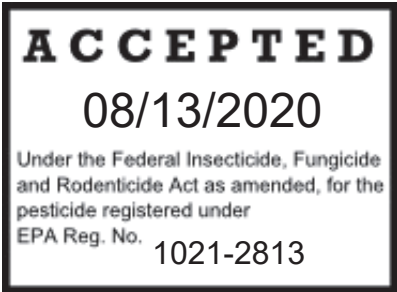

AGRICULTURAL USE REQUIREMENTS

This standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. To reduce infestation of darkling beetles in poultry litter:

TO REDUCE DARKLING BEETLE INFESTATIONS IN POULTRY LITTER:

Comfort Zone® Insecticide and Sodium Bisulfate are to be used together for optimal effectiveness. Pyrethrum is subject to alkaline hydrolysis and breaks down in a matter of hours above pH 9. The pH of poultry litter is typically between 9 and 10. The application of sodium bisulfate will reduce the litter pH below 7 allowing the pyrethrum to remain active.

Sodium bisulfate can be applied in the poultry house directly before or in conjunction with Comfort Zone® Insecticide using a fertilizer spreader. Apply the sodium bisulfate at a rate of 50 – 200 lbs/1000 sq. ft. depending on the amount and age of the litter. A poultry house with a small amount of litter will to 50 lbs/1000 sq. ft., a poultry house with a large amount of old litter will require 200 lbs/1000 sq. ft. Apply the Comfort Zone® Insecticide at a rate of 1 – 2 lbs/1000 sq. ft. in areas typically high in darkling beetle infestation. These areas include next to sidewalls and under feed and drinking water lines.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

PESTICIDE STORAGE: Keep this product in its tightly closed original container, when not in use. Do not store near heat or open flame. Store in a cool, dry, well-ventilated (preferably locked) area that is inaccessible to children and animals, and away from food and pet food.

PESTICIDE DISPOSAL: To avoid wastes, use all material in this container by application according to label directions. If wastes cannot be avoided, offer remaining product to a waste disposal facility or pesticide disposal program (often such programs are run by state or local governments or by industry).

CONTAINER HANDLING: Non-refillable container. Do not reuse or refill this container. Completely empty container by shaking and tapping sides and bottom to loosen clinging particles promptly after emptying. Then offer for recycling if available or reconditioning, if appropriate or dispose of in a sanitary landfill or by other procedures approved by state and local authorities.
