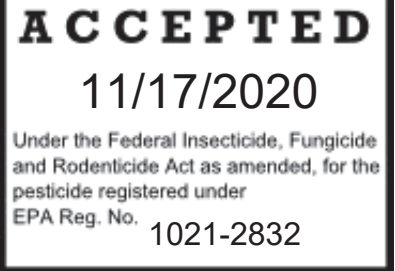

SHAKE WELL BEFORE EACH USE

This product will not stain water-safe fabrics and surfaces; however, care should be taken to test a small hidden area for staining prior to use.

- HOLD CONTAINER UPRIGHT WITH NOZZLE POINTED AWAY FROM YOU.
- PRESS VALVE AND SPRAY FROM A DISTANCE OF 8 TO 10 INCHES.
- Spray area, directly contacting as many listed pests as possible.
- For best result spray when air is calm allow for drift if spraying in slight breeze.
