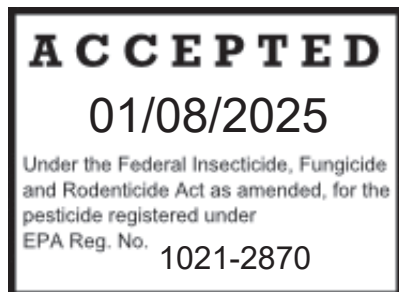

- For outdoor use only.
- Do not use indoors.
- Do not make applications during rain.

**APPLICATION RESTRICTIONS**

- Outdoor applications are limited to direct applications to pest in spot, crack and crevice sites.

- Spot must not exceed two square feet in size (for example 2 ft by 1. ft. or 4 ft. by 0.5 ft).
- Crack and crevice must not exceed 1 ft. by 100 linear ft.

Ants (excluding carpenter, harvester, pharaoh and red imported fire) boxelder bugs, brown marmorated stink bugs, and houseflies.

## **USE AREAS**

For use outdoors on the exterior vertical surfaces of the listed man-made structures: commercial warehouses (non-food), commercial buildings, office buildings, theaters, hotels, motels, homes, garage buildings, resort buildings, industrial buildings, apartment buildings, dumpsters/trash cans, commercial kennel buildings, commercial horse stable buildings, zoo buildings.

[This product should not stain or cause damage to painted surfaces or plastic siding, or other vertical surfaces where water applied alone causes no damage. Treat a small area and allow it to dry to determine whether staining will occur.]

Direct spray treatment to pests in spot, crack and crevice sites.

## **MIXING INSTRUCTIONS**

Clean equipment before and after use. Dilute MGK Formula 3159 with water only. Agitate the container of MGK Formula 3159 before diluting by inverting it several times. For dilution, add approximately half the required water to the tank and then add the appropriate amount of MGK Formula 3159. Agitate and slowly add the remaining water. Agitate the mixture thoroughly before using and occasionally during use to ensure dispersion. Do not apply to the point of runoff.

## STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

### PESTICIDE STORAGE:

Store in a cool, dry place. Always store pesticides in the original container. Store away from food and pet food.

### PESTICIDE DISPOSAL:

To avoid wastes, use all material in this container by application according to label directions. If wastes cannot be avoided, offer remaining product to a waste disposal facility or pesticide disposal program (often such programs are run by state or local governments or by industry).

### CONTAINER HANDLING AND DISPOSAL:

Non-refillable FL-HDPE container greater than 5 gallons (18.9 L). Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows [for Non-refillable FL-HDPE containers greater than 5 gallons (18.9 L)]. Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling if available, or puncture and dispose of in a sanitary landfill.

[For totes/55 gal Non-refillable FL-HDPE containers] [For 30 gal. Non-refillable FI-HDPE containers]

[Pressure rinse as follows: Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 psi for at least 30 seconds. Drain for 10 seconds after the flow begins to drip. Then offer for recycling if available, or puncture and dispose of in a sanitary landfill.]

[For Refillable FL-HDPE Containers]

[Refillable FL-HDPE containers greater than 5 Gallons.. Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning before refilling is the responsibility of the refiller. To clean the container before final disposal, empty the remaining contents from this container into application equipment or mix tank. Fill the container about 10 percent full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into rinsate collection system. Repeat this rinsing procedure two more times. Offer for recycling if available or reconditioning if appropriate, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.]
